I, Smt Sabita Deb Nandi, wife of Sri Subir Nandi, daughter of Sri Biplab Kanta Deb, presently residing at- Ashighar More, Beside Ghosh Sweets, Chayan Para, District- Jalpaiguri, Pin code- 734006 intend to lodge this complaint against Sri Bijoy Sarkar and his wife to the effect that I met Sri Bijoy Sarkar during one ceremony. Thereafter one friendship relation was developed between me and said Bijoy Sarkar. Subsequently, said Bijoy Sarkar started to demand some intimate pictures from me as said Bijoy Sarkar started to develop feelings towards me. Thereafter in the month of February 2023 I had shared some intimate pictures with said Bijoy Sarkar and asked him to delete those pictures immediately and he assured me the same. Thereafter in the first week of March 2023 said Bijoy Sarkar started to demand intimate pictures from me on a regular basis over telephone. Upon denial Bijoy Sarkar started to abuse me and give me threats over telephone that he would viral the pictures to my in-laws and over social media and started to demand cash amount from me with the malafide intention to extort me and destroy my reputation. In the last week of March 2023 said Bijoy Sarkar visited my house with an intention to harm me but out of fear I

did not open the door. Thereafter Bijoy Sarkar abused me over telephone with filthiest languages and threatened me to send my private pictures to my husband. On 06.04.2023 at around 9.00 pm said Bijoy Sarkar had forwarded my naked pictures and some messages to my husband from one whatsapp being number 9547453828 in my husband's whatsapp number being 8101593251. Thereafter on 13.04.2023 at around 9.00am I had received sms on my whatsapp number from Sri Bijoy Sarkar and his wife. I am afraid that said Sri Bijoy Sarkar will viral my unseen pictures over social media and to my in-laws and harm my family and my minor child as said Bijoy Sarkar has the knowledge about our whereabouts and said Bijoy Sarkar on several occasion had visited my house in the absence of my husband. Said Bijoy Sarkar is tremendously threatening to viral my unseen pictures in social media and ruin my career with the malafide intention to extort money for their illegal gain. Said Bijoy Sarkar is also trying to reach my in-laws residing in Gangarampur over social media to spread the illegal acts stated above.

Finding no other alternative, I am lodging this complaint before you against Sri Bijoy Sarkar and his wife to the effect with the aforesaid incident. I was unable to lodge the complaint immediately after the aforesaid incident as the matter was very sensitive and shameful. Kindly consider the same.
