Sub – Complaint With Respect To A Cyber – Crime

Respected Sir,

Most respectfully I beg to submit the following :

1. That I, Aparna Mishra D/O : Sanjay Mishra from Siliguri , Rajendra Prasad Road Ward No 41 , Shastri Nagar , Siliguri (M.Corp.) , Jalpaiguri Sevoke Road , West Bengal -- 734001 draw your kind attention to the following facts.
2. That I got introduced with one boy named Vikash Kumar Jha @ VikashJha S/O ArjunJha , R/O Sonewati , P.O Pathrahi P.S Babubadai , District Madubani , Bihar having phone No. 9631902905, 07903681310 through facebook.
3. That gradually our relationship developed as we both used to interact over phone call and video call as well.

Although he did not give me details about him but always said that he was calling from Bihar or from Delhi or Dubai as well. He sent some air tickets to claim his visit to Dubai.

He insisted for sending my indecent and ugly pictures through video call and demanded continuation of the same regularly. Sometimes I had to agree to his request reluctantly but on refusal he threatened me too.

He also somehow collected the names and numbers of my relatives and friends through facebook and instagram and collected information about me but when I felt his ill-intention of blackmailing me I gradually withdrew myself and tried to avoid him after May p2022.

4. That I never met him whatever our communication was there it was only on video call and I was taken aback when I came to know that he conveyed all our communications to my friends and relatives including my pictures as well.
5. That he rang me again and again with an intention to intimidate me that if I stop communicating with him he would make the same viral. Infact I failed to understand his intention but it was definitely meant to defame and lower me down in public and also to humiliate and cause injury to my character since I am a girl aged 18 years and a student of class 11 (Eleven).
6. That I have stopped all my communications and relationship with him since October 2022 and he is found conveying and dispatching all our communications with photographs to all my relatives and friends which amounts to commission of criminal offence.

I therefore request you to take immediate action against him.
