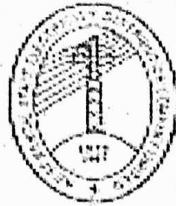

Sub:- Intimation of Stolen Isolator Base and Electrical Material.

Dear Sir,

I am writing to bring to your attention the unfortunate incident of stolen isolator base and electrical materials from two separate locations in Amaidhighi, near the Border Roads and near the Primary School. I wish to formally inform the Njp Police Station about these incidents.

The first incident occurred at the Amaidhighi Katun Factory, where the isolator base and electrical materials were stolen on 12.04.2023. The second incident occurred at a location near the Primary School in Amaidhighi on 12.04.2023, where similar items were stolen. The estimated value of the stolen items is 2500. As the rightful owner of these stolen items is wbsecl, I request your assistance in investigating the matter and taking appropriate action to recover the stolen property and bring the culprits to justice. I am also willing to provide any additional information or evidence that may aid in the investigation. I kindly request that the Njp Police Station also take swift action in this matter and keep me informed about the progress of the investigation. Take necessary steps to prevent such incidents in the future to ensure the safety and security.
