Sir,

I, SI-Pradeep Dyal of New Jalpaiguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the unknown mob of approximately 4,000 supporter of DYFI [Democratic Youth Federation of India] & SFI [Student Federation of India] to the effect that today on 13.04.2023 at about 0800 hrs myself along with other officers and Force including lady force were detailed to perform Law and Order duty at Tinbatti More, PS- New Jalpaiguri PS, Siliguri Police Commissionerate under the supervision of the senior officers as per Police Arrangement vide Memo No.- 959/SB/SPC dated: 12/04/2023 in c/w Uttar Kanya Abhijan organised by DFYI, West Bengal State Committee [Democratic Youth Federation of India] and SFI [Student Federation of India]. vide New Jalpaiguri PS SPL MCC No.- 734/23, 735/23, 736/23, 737/23, 738/23, 740/23, 741/23, 742/23, 743/23, 744/23, 745/23, 746/23, 747/23, 748/23, 769/23, 760/23, 761/23, 764/23, 765/23, 766/23, 767/23, 768/23, 769/23. This refer New Jalpaiguri PS GDE No.- 557 date: 13.04.2023. As per Police Arrangement vide Memo No.- 959/SB/SPC dated: 12/04/2023 two number of water canons were deployed to avert any untoward incident at Tinbatti More, as well as loud hailer was also deployed to make crowd inform about any kind of assembly of the programme in the area to be unlawful. The propose of the programme organised by DYFI [Democratic Youth Federation of India] & SFI [Student Federation of India] is to enter at "Uttar Kanya" Mini-Secretariat of North Bengal with huge Mob of 4,000 approx with the various demand. It is pertinent to mentioned here that the "Uttar Kanya" is highly security zone is under the coverage of Section 144 Cr.P.C vide CO No.- 769 dated: 25/02/2023 for the period of sixty days w.e.f 27th February, 2023 to 27th April, 2023 as Order by the Commissioner of Police, Siliguri Police Commissionerate. Since 1000 hrs all the members of DYFI [Democratic Youth Federation of India] & SFI [Student Federation of India] were started assembled at Air View More under Siliguri Police Station, Siliguri Police Commissionerate and at about 1345 hrs the Leaderless mob of approx 4,000 is proceeded towards "Uttar Kanya" from Noukaghat side. To prevent any physical confrontation with the worker of DYFI & SFI all the barricade are properly installed at Tinbatti More. While the mob of 4,000 approx proceeding from Noukaghat Side towards Tinbatti Side the above noted accused persons to instigate the Mob and creating violance and vabdaslisim and attacking agaisnt Police Personals if Police Personal to proceeded towards "Uttarkanya" with various demand. All the Mob has been stopped at Tinbatti More and the senior officer who were detailed to perform Law and Order Duty at Tinbatti vide Memo No.-959/SB/SPC dated: 12/04/2023 impart clear instuction the inability to proceeded towards "Uttar Kanya" as the whole area is under the coverage of Section 144 Cr.P.C as well as the mob was also acknowledge them by loud haler to disperse immediatley and warn them reagarding the situtation. But the Leaderless Mob of 4,000 Approx did not pay any heed to the instuction given by the detailed superior as well as information impart from the loud haler.

After giving proper instruction by detailed superior officer as well as in loud hailer to go back and continue their programme at Nougaghat area but they failed to obey the instruction but instead the crowd became furious and forcefully they tried to proceed towards "Uttar Kanya". Suddenly, a section of the crowd started pelting stones towards detailed Police Personnel and started attacking detailed Police Personnel with Bambo Stick and other. Consequently, number of Police Personnel sustained injuries on their person and some Public property was vandalized by mob as well as some unknown persons also threatened the Police Personnel with dire consequences.

Finding no other alternatives, detailed Police Team as per Order, the Police Team charging Tear Gas to disperse the crowd. After some time the section of Mob withdrew back. But after a while the section of Mob again started pelting stones towards Police Personnel. After some time at about 1445 hrs finally the situation could be taken into control. During whole process, security of life of every person and dignity of ladies has been taken care of.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the unknown persons and mob of 4,000 [Four Thousand] supporters of DYFI [Democratic Youth Federation of India] & SFI [Student Federation of India] and arranged for its investigation of the case.
