Sir,
I, Bablu Kumar Rathi, S/O Ram Jiwan Rathi, resident of Navjiwan Apartment, Panjabi Para, P.O and P.S Siliguri, District Darjeeling, do hereby lodge the written complaint on the following:

That I am one of the partners of LLP Limited Liability Partnership Firm under the name and style Yellow Shield Infra LLP having its office at Sikhadeep Building, Third Floor, Sevoke Road Siliguri.

That our above named firm purchased a well demarcated butted and bounded land measuring about 384.80 decimal appertaining to and forming part of R.S. Plot NO. 17, 18, 19, 20, 21 corresponding to L.R. Plot No. 25, 28, 27, 29, 30, 31 recorded in Khatian No. 8/1, 8/5, 8/9, 8/11, 8/13 situated within Pargana Baikunthapur, Mouza - Ambari Falakata of Sheet No.1, P.S. New Jalpaiguri in the District of Jalpaiguri by virtue of a Deed of Conveyance duly registered in the office of the Additional District Sub Registrar, Bhaktinagar on 3/06/2022 being document No. 5575 for the year 2022.

That since the purchase of the land our firm is having right, title, interest, ownership and is in actual, peaceful, Khas possession over the aforesaid land by demarcated by specific boundary.

That the aforesaid land was purchased by our company to bring factory/ industry (MSI) over there which in turn will not only generate employment opportunities but also bring all round development in the locality.

That we have employed few staffs for cleaning and other constriction activities, on 06.04.2023 at about 2:30pm some local miscreants namely Aliyar Rahaman Son of Romjan Ali, his three sons namely Asad Ali, Jaker MD. and Farun Md. along with Atabul Md. and Sahajan Md both Sons of Asad Ali by forming an unlawful assembly along with sharp weapons, daggers, knife, lathi, sickle, spade etc, started banging the main gate and when our staff was opening the gate, they pushed and stormed into the compound with a view to commit murder and threatened us to stop all our activities immediately and if we fail to leave the site they would not hesitate to kill us and thus criminally intimidated us along with threat to life and warned that they would not hesitate to spill our blood. The aforesaid persons are the well known land grabbers in the locality and Asad Ali, Atabul Md and Jaker Md was abusing us with filthy languages, constantly showing us dagger and sickle and stating that in no time they will kill us.
