Subject : Complaint regarding land trespassing

Respected Sir/Madam,

I beg to state that I am Mr. Rajendra Kumar Maheshwari, S/o. - Late Kishori Lal Maheshwari aged about 74 Years, resident of Raikatpara, Jalpaiguri. I had bought a piece of Land alongwith Mr. Samir Maheshwari, Mr. Vivek Maheshwari and Mr. Surendra Maheshwari bearing LR Khatian No. 1331 and Plot No. 364, 365, 367, 368 admeasuring an area of about 200 decimal in Binnaguri Mouza, Sheet No. 17, JL No. 3, District - Jalpaiguri in the year 1982 by virtue of deed no. I-672, I-671, I-1095 & I-1096 registered at D.S.R., Jalpaiguri. Since I was not using it, it was left unattended. The area was covered by bricks boundary wall.

Recently, while visiting the said property on the right side of National Highway towards Jalpaiguri adjacent to Fulbari Town and the plot is having electricity transformer, I realised that the boundary wall requires repair and maintenance. Eventually on 6th April, 2023, when I went to the plot alongwith masons to start the repair work, I was disturbed by Mr. Hafizul Rahaman and his son Farooque Husain resident of Fulbari Hat, Jalpaiguri from carrying on the repair works.

Even after several requests, they continue to trespass my property illegally & disturb construction work forcefully. They were also verbally very abusive during the discussion and have threatened me of dire consequences.

Therefore, I would like to request your kind good self to register this complaint as a FIR against Mr. Hafizul Rahaman and his son Farooque Husain as stated above.

I shall be grateful for your strict action against the aforesaid incident and kind co-operation in this matter.
