1. That Smt. Pasang Lama (Sherpa) Wife of late Wangdi Lama i.e. was the mother of my Wife Smt. Dalamu Lama ( Dukpa) and she expired on 10/03/2023 leaving behind her only one Legal heirs i.e. my wife Smt. Dalamu Lama ( Dukpa) to inherit her all properties .
2. That during the life time of my mother in-law Smt. Pasang Lama (Sherpa) the above named person and their associates use to torture all the family members physically and mentally and always tried to encroach /Grab the properties as fully described in the schedule below in an illegal manner and unlawfully by showing their Muscle Power.

That since the death of my mother in law the illegal act and activities of the above named person and their associates have been increased rapidly and they are threatening me that they would kill me if I interfere or try to stop their illegal act and activities to grab my land or file any complaint against them to any Police station.

That the above named person with the help of their antisocial elements are not allowing me and my wife to enter into the said land and they are using the said land for their illegal act and activities unlawfully and they have given my one of the room on rent to open a Medicine shop in an illegal manner unlawfully forcefully by using criminal force without asking from me or my wife or our consent unlawfully & illegally .

That the above named parson are continuously threating me and my wife and torture us physically and mentally and now a days they are threating on Mobile from Mobile No- 918389834167 they call and threaten and demanding Rs. 50 lakhs to 60 lakhs in cash to vacant my said land and if I fail to pay then they will kill/murder as they are having the blessing of Dawoot and no one can do anything to them .
6. That I and my other family members are in fear as on any moment the above mentioned can do anything to us for the said Land as they are land Mafias and can adopt unlawful method.
7. That the above named persons are very dangerous in nature and they can do anything to grab the said land of my wife by adopting illegal means and can prepare fake documents in their name dishonestly for their illegal gain & benefits .
