On routine inspection, I, Suman Sengupta, DE & SM, Power House CCC along with Sanjay Prasad, Sr. Office Executive, Power House CCC visited the premises of consumer against Rabi Agarwalla, 2 & 1/2 Mile, Sevoke Road, Siliguri, Dist Jalpaiguri bearing Consumer Id: - 412035299 & Energy Meter No: -SF604307 (Make- Secure Meters Ltd, 240v, 5-30 Amp. Three Phase) having a Commercial connection. The site being at 2 & 1/2 Mile, Sevoke Road, Siliguri, Dist Jalpaiguri. We entered the consumer premises on 17.04.2023 at 13:55 Hrs. On inspection it was found that the meter was not present physically on the site. The Price of the missing item is Rs 9454/- (approx), other than the actual units consumed and are to be billed yet. We exited the premises on 14:10 Hrs.
