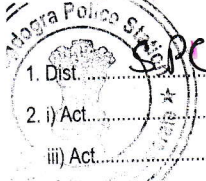

I, SI Binup Mahato of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Gita Barman (Roy) (40) W/o Lt. Tiren Roy of Kestopur, Chowpukuria PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

1. Fifteen (15) nos sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.
2. Ten (10) Ltrs Local made ID Liquor locally called as "Cholai" which kept in two Plastic Jar, each 5 Ltrs, Marked as Exhibit -B in which 01 Ltr taken as sample in a Plastic bottle for examination exhibit-B1.

I am submitting a written complaint against the above noted accused person to the effect that today on 13.04.23 at 14-30 hrs Myself alongwith VP-02 Pradip Roy CV- 389 Janak Singh, LCV-099 Rohita Minz, LCV-098 Shilpa Karmakar were performing Special evening Mobile duty vide Bagdogra PS GDE No. 595 dt. 13.04.23. At 15-05 hrs received secrete source of information that one female person was selling Id Liquor illegally from her house at Kestopur, Chowpukuria to its customers without any valid license. Accordingly I informed the matter to O.C. Bagdogra PS and as per his instruction myself alongwith and force left for Kestopur, Chowpukuria to verify the veracity of information. On arrival at the spot at 15-25 hrs it was found that one lady mentioned above was selling liquor illegally from her house at Kestopur, Chowpukuria to designated customers to earn huge money for her livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police. On being asked she disclosed her name and address mentioned above. Thereafter in presence of witnesses I recovered (1) Fifteen (15) nos sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml and (2) Ten (10) Ltrs Local made ID Liquor locally called as "Cholai" which kept in two Plastic Jar, each 5 Ltrs from the possession of the apprehended lady from her house and seized the same as per proper seizure List and labelled duly signed by her and also witnesses. On being asked she failed to produce any document or license for selling the liquor and confessed her guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C with the help of lady force as It's a violation under Bengal Excise Act with strictly maintaining her modesty. This seizure & arrest was made in between 15-35 hrs and 16-05 hrs (seizure Total approx 19 Ltrs).

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Gita Barman (Roy) (40) W/o Lt. Tiren Roy of Kestopur, Chowpukuria PS Bagdogra Dist. Darjeeling and arrange for its investigation.
