Respected Sir,

I, **SMT. TUHINA DAS**, Wife of Sri Shyamal Chandra Das, resident of Pradhan Nagar, Purbanchal, Ward No. 2, near Ravi Ratna School, Small Gate, P.O. & P.S. Pradhan Nagar, District -Darjeeling would like to inform and request you as follows:

1. That I got married to one Sri Shyamal Chandra Das, long back in the year of 1986, and from the wedlock we have a son namely Rahul Das and a daughter namely Puja Das and both of them are major now and in fact our daughter has been married since 1 year.

2. That after marriage I came to know that my husband is very violent and aggress in nature and used to torture me physically and mentally even in petty issues. My husband never showed any interest in me and our children and was very arrogant and rude towards us and neglected our needs. Whenever I used to ask for financial assistance from my husband, he used get aggressive and start hitting me and throwing things at me. However with the help of my parents and close relatives and friends I somehow managed to raise our children.

3. That after few years of our marriage I came to know that my husband was having affair with one another woman namely Smt. Sandhya Sarkar and when I asked him about the same he left our home and started living with said Sandhya Sarkar at my house situated at Maheshmari, Banbasti, Debidanga P.O. Champasari, P.S. Pradhan Nagar near New Sunrise School. It is to be mentioned here that the said affair lasted for 15 years and during that time I requested my husband several times to leave that woman but he refused to do so and threatened me that if I do anything he will make our life hell and for the sake of my children I kept mum and did not take any action against my husband.

It is pertinent to mention here that even though my husband was staying with the abovementioned woman in my aforementioned house, he often used to visit us and ask for money and when I refused, he used to create chaos and would torture me by hurling abuses and beating me with whatever came in his hands.

4. That after my husband got separated with the abovementioned woman in the year 2022, however said lady started living at a portion of my said land without my permission and inspite of my several request refused to leave my land and my husband Shyamal Chandra Das came back to me and promised me and our children to never do anything such again and trusting on his words I forgave him but after sometime he again started torturing me physically and mentally by using various means and when I enquired about the reason of

his such behavior I came to know that he again got involve with another woman namely Shayami Saha and on asking about her my husband ruthlessly assaulted me by beating me and as my son was not present at that time nobody was available there to rescue me and thereafter he left the house.

5. That thereafter all on a sudden my husband came to the house with the said Shyamali Saha and said that he got married to her and after taking his clothes and articles left the house and then went to my another house situated at Maheshmari, Banbasti, Debidanga P.O. Champasari, P.S. Pradhan Nagar near New Sunrise School. Having Khatian No. 1017 within Mouza - Mahishmari and started residing at a portion of the house constructed over the said land.

However my husband and said lady namely Shyamali Saha have been visiting our house frequently in absence of my son and demands money from me and on my refusal both of them assaults me physically and abuses me by using filthy languages which creates tremendous mental torture upon me.

6. That recently on 14.04.2023, my husband and said Shyamali Saha entered in my residence forcefully in the absence of my son and started asking me to transfer my said house in which they are illegally staying presently in their name and when I refused they both started abusing me and also started beating me by fist and blows and at the time of leaving my residence they also threatened me that if I take any action against them they will beat me to death and being very much frightened by their such activities I did not even share this fact to my son however yesterday again my husband came to my hose and again threatened me that if I do not accept his proposal then he will not spare our children also.

7. Sir, for last 36 years I have tolerated my husband's every inhuman mental and physical torture, his affairs, his arrogant and rude behavior towards me and our children and even now also I am living in a constant fear because of all tortures and threats of killing me by my husband and said Shyamali Saha, But I kept mum for the sake of our family but the last threat by my husband compelled me to come before you with this complaint.

Therefore you are humbly requested to look after the matter and take strict action against the culprit and by folded hands, I am requesting you to initiate a criminal case against them, and treat the present complaint as F.I.R.
