In producing herewith one accused person namely Pruthviraj Satish Adagale (20) S/O Satish Adagale of Khedbhalvani ,Chandini Chowk ,Khed Bhalawani, Solapur Shelve Maharashtra 413304 in custody and the following property under seizure along with seizure list:-

i. One Silver Batt marked as E-75 Measuring 2602.010 Gram and Marked as exhibit-"A"

ii. One Silver Batt marked as E-76 Measuring 4060.600 Gram and Marked as exhibit-"B"

iii. One Silver Batt marked as E-77 Measuring 4894.600 Gram and Marked as exhibit-"C"

iv. One gray colour bag stayed as SBD containing the above note 03 exhibit marked as Exhibit "D"

I, S.I. Kalyan Saha of Pradhannagar Police Station, SPC do hereby lodged this complaint to the effect that on 25.04.23 at 13:35 Hrs received an information from on duty officer ASI Suresh kami of Pradhannagar Police station that one Uttam Ghosh S/O Lt Kumud Bihari Ghosh of 61 Nazrul Sarani Hakimpara PO+PS Siliguri Dist Darjeeling, Depot In Charge of NBSTC Siliguri informed that three of their on duty checking staff namely 1)Pradip Barman s/o Lt Anath Barman 2)Kamal Paul s/o Lt Gopal Paul 3)Chandra Sekhar Dey s/o Lt Atul Ch Dey while checking NBSTC bus bearing Registration No. WB 63 5098 proceeding towards Siliguri, At that time they detain one Pruthviraj Satish Adagale (20) S/O Satish Adagale of Khedbhalvani ,Chandini Chowk ,Khed Bhalawani, Solapur Shelve Maharashtra 413304 with 03 no of gold like substances in a black colour sholder bag. Then they took the boy with them and came to Siliguri NBSTC Depot and informed Pradhannagar PS This refers to Pradhannagar PS GDE No 1517 Dated 25-04-2023. As per instruction I SI Kalyan Saha SI Atanu Majumdar C/735 Swapan Sarkar C/207 Niladri Sarkar VP 09 Sanjib Kodalia CV 1035 Sanjib Oraon went to Siliguri NBSTC Depot to verify the veracity of information and after reaching the NBSTC depot siliguri found one person was detained by the said people with 03 gold like substance. I interrogate the detained person and he admits that the said substances are silver in nature.

Accordingly I along with SI Atanu Majumdar C/735 Swapan Sarkar C/207 Niladri Sarkar VP 09 Sanjib Kodalia CV 1035 Sanjib Oraon and Uttam Ghosh S/O Lt Kumud Bihari Ghosh of 61 Nazrul Sarani Hakimpara PO+PS Siliguri Dist Darjeeling Depot In Charge of NBSTC Siliguri and Sumit Ghosh s/o Narayan Ch Ghosh of Paticolony Road No 04 Pati colony goli no 04 PS Matigara Dist Darjeeling went to Star Hallmarking Center, 181/2 Hillcart Road, opposite of Bata Hotel Niladri Plaza 1st floor Siliguri Dist Darjeeling to check the actual weight and genuinity of the substances. Then one Sk Ziauddin s/o Sk Nazibar Rahaman of Kangsaripur Bhastra Hoogly the XRF in Charge of Star Hallmarking Centre Siliguri confirmed that the gold like substance is Silver (Chandi) in nature. Accordingly I asked the detained person to show the papers regarding the substances but he failed to produce any relevant documents regarding the said articles. Accordingly I seized the above noted Silver butts in presence of Uttam Ghosh S/O Lt Kumud Bihari Ghosh of 61 Nazrul Sarani Hakimpara PO+PS Siliguri Dist Darjeeling Depot In Charge of NBSTC Siliguri and Sk Ziauddin s/o Sk Nazibar Rahaman of Kangsaripur Bhastra Hoogly the XRF in Charge of Star Hallmarking Centre Siliguri and arrested the detained accused person namely Pruthviraj Satish Adagale (20) S/O Satish Adagale of Khedbhalvani, Chandini Chowk, Khed Bhalawani, Solapur Shelve Maharashtra 413304 informing the ground of arrest. He also admitted that he along with his associates collected the silver(Chandi) fraudulently here and there and sell in different market for their wrongful gain. The whole process of seizure and label was done in between 14:45 Hrs to 15:50 Hrs.

Therefore, under the above circumstances, I pray before you that a specific case may kindly be started against the accused person namely Pruthviraj Satish Adagale (20) S/O Satish Adagale of Khedbhalvani ,Chandini Chowk ,Khed Bhalawani, Solapur Shelve Maharashtra 413304 and arrange for its investigation.
