This is to inform you that two employees of my shop namely Prasanjeet Dutta and Rajiv Mondal found involved in burglary of stock from my shop by opening my shop by duplicate key.

That yesterday i.e. on April 20, 2023 at about 8.00 PM I closed down my shop premises and left for home but one Mr. Sanjiv Gupta booking Agent from Kolkata rang me up as he left his belonging in my shop and on his request I turned back to my shop at about 8.20 PM from the way and when I reached to my shop I found the shutter of shop open and above named employees of my shop were found packing goods and it was a big surprise to me that they opened the shop premises behind my back by duplicate keys to take away the goods with them.

That I resisted them to remain inside the shop premises till the Police van to come but I could not hold them and they fled from the shop premises leaving behind their Scooty being Registration No. WB-74-BM-4017.

That I was experiencing shortage of stocks in my shop for last many days but I could not track it.

That only today I could catch the culprits red handed as above named but could not hold them up for a long and both of them fled away from the shop. A detailed information is given below to your good office after assessing the stock.
