Sir,

With due respect, I am producing herewith the arrested accused persons namely (i) Biswanath Shil (23) S/O Ranjit Shil of Jhankar More, P.S- Siliguri, Dist.- Darjeeling, (ii) Belal Md. (20) S/O Nazrul Haque of Sitaguri, P.S- NJP, Dist.- Jalpaiguri, (iii) Babu Barman (33) S/O Lt. Amar Barman of Shantipara, P.S- NJP, Dist.- Jalpaiguri, (iv) Sourav Das (23) S/O Ratan Das of Udaynagar, Sri Ram Pally, Srinagar Colony, P.S- NJP, Dist.- Jalpaiguri and the following articles under seizure :-

1. One Iron made Hasua from the possession of accused Biswanath Shil (23) S/O Ranjit Shil of Jhankar More, P.S- Siliguri, Dist.- Darjeeling.
2. One sharp cutting knife and one Iron Road from the possession of accused Belal Md. (20) S/O Nazrul Haque of Sitaguri, P.S- NJP, Dist.- Jalpaiguri.
3. One Iron Hammer & One Blunt Iron Rod from the possession of Babu Barman (33) S/O Lt. Amar Barman of Shantipara, P.S- NJP, Dist.- Jalpaiguri
4. One Blunt Iron Road & One Torch Ligh from the possession of accused Sourav Das (23) S/O Ratan Das of Udaynagar, Sri Ram Pally, Srinagar Colony, P.S- NJP, Dist.- Jalpaiguri

1. ASI Sajal Das of NJP PS, Siliguri Police Commissionerate beg to state that on 21.04.2023 at 22.05 hrs I received a secret source information that a gang of miscreants come to Thakurnagar near Sat Sangha Ashram with deadly weapons and assembled there and making preparation for committing dacoity at Thakur Nagar area. Accordingly, I informed the fact to you and diarized the fact in General diary vide NJP PS GDE No 922 dated 21.04.2023. As per kind order myself along with ASI Khagen Barman, VP/13 Jamirul Islam, VP/08 Laxman Roy, CV/306 Bisawajit Roy CV/824 Niru Kumar Yadav all are of New Jalpaiguri PS, Siliguri Police Commissionerate left for Thakurnagar area near Sat Sangha Ashram, PS-New Jalpaiguri, Dist.- Jalpaiguri to work out the information in hand. I also informed the fact to night RT Van officer ASI Bhai Chandra Tamang of New Jalpaiguri PS, Siliguri Police Commissionerate along with force and directed him to come to Gora More to accompany with us. At about 22.20 hrs on 21.04.2023 we arrived at Thakurnagar near Sat Sangha Ashram, PS-New Jalpaiguri PS, Siliguri Police Commissionerate. After a while ASI Bhai Chandra Tamang along with force came to Thakurnagar area near Sat Sangha Ashram and accompany with us. After arrival of the spot and as identified by the source we found that 10/11 persons assembled in a dark place at Thakurnagar area near Sat Sangha Ashram, under New Jalpaiguri PS, Dist.- Jalpaiguri and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 04 (Four) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above and also disclosed that they assembled there to commit dacoity in a house at Thakurnagar area. On search of the apprehended accused persons I found (i) One Iron made Hasua from the possession of accused Biswanath Shil (23) S/O Ranjit Shil of Jhankar More, P.S- Siliguri, Dist.- Darjeeling (ii) One sharp cutting knife and one Iron Road from the possession of accused Belal Md. (20) S/O Nazrul Haque of Sitaguri, P.S- NJP, Dist.- Jalpaiguri (iii) One Iron Hammer & One Blunt Iron Rod from the possession of Babu Barman (33) S/O Lt. Amar Barman of Shantipara, P.S- NJP, Dist.- Jalpaiguri (iv) One Blunt Iron Road & One Torch Ligh from the possession of accused Sourav Das (23) S/O Ratan Das of Udaynagar, Sri Ram Pally, Srinagar Colony, P.S- NJP, Dist.- Jalpaiguri. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally they admitted their guilt and disclosed that they had assembled there and taking preparation for committing dacoity in a house at Thakurnagar area. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted four accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made in between 22.45 hrs to 23.20 hrs.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely i) Biswanath Shil (23) S/O Ranjit Shil of Jhankar More, P.S- Siliguri, Dist.- Darjeeling, (ii) Belal Md. (20) S/O Nazrul Haque of Sitaguri, P.S- NJP, Dist.- Jalpaiguri, (iii) Babu Barman (33) S/O Lt. Amar Barman of Shantipara, P.S- NJP, Dist.- Jalpaiguri, (iv) Sourav Das (23) S/O Ratan Das of Udaynagar, Sri Ram Pally, Srinagar Colony, P.S-NJP, Dist.-Jalpaiguri and others and arrange for its investigation.
