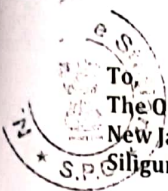

Sir,

With due respect, I am producing herewith the arrested accused person namely Md. Hussain (40) S/O Lt. Md. Abdul Matib of Vill- Chocha, P.O- Gangar Ghosh, P.S- Baisi, Dist- Purnia (Bihar) and the following articles under seizure :-

1. One truck Dala body having registration number WB 59 C 0167 loaded with 19 (nineteen) numbers of big size Buffalo in balack colour (Buffalo)

I, SI Newton Biswas of NJP PS, Siliguri Police Commissionerate beg to state that on 23.04.2023 at 23.35 hrs I received a secret source information that one vehicle having registration number WB/59C/0167 loaded with stolen Cattle (Buffalo) which were procured by stolen or fraudulent means are coming from Ghosh pukur side. Accordingly, I informed the fact to O/C, NJP PS and dirised the fact in general diary vide NJP PS GDE No-1030 dated 23.04.2023 and as per order myself along with VP/08 Laxman Roy, VP/13 Jamirul Islam, CV/306 Biswajit Roy, CV 824 Niru Yadav left for Fulbari Toll Plaza to work out the information in hand. At about 00.05 hrs on 24.04.2023 we arrived at Fulbari Toll Plaza and started Naka checking in order to intercept the said vehicle. At about 00.35 hrs we noticed that the above noted vehicle coming from Ghosh Pukur side and proceeded towards Assam side. We managed to intercept above noted vehicle at Fulbari Toll Plaza. On verification we found person is seating inside vehicle No WB/59C/0167 he disclosed his Identity as Md. Hussain (40) S/O Lt. Md. Abdul Matib of Vill- Chocha, P.O- Gangar Ghosh, P.S- Baisi, Dist- Purnia (Bihar) and on being search it is found that 19 (nineteen) numbers of Cattle (Buffalo) all are in Black colour loaded in the said vehicle. On demand he failed to produce any valid documents/purchase invoice in respect of carrying Buffalo in his respective vehicles. He also failed to produce any permit for carrying livestock in the vehicles and also failed to prodeuce any medical check up certificate in respect of such Cattle (Buffalo) which is a mandatory provision of law before transporting of Cattle (Buffalo). I also asked him to produce any supporting documents in respect of carrying/transporting the Buffalo if any but he failed to produce the same. During further interrogation he admitted that Buffalos were procured by some Buffalos smugglers by illegal means from Bihar side in order to supply the same to Assam to make huge profit.

During physical verification, it is found that the Cattle (Buffalo) were loaded in such a manner which caused unnecessary pain and suffering to those Buffalos as there was no reasonable space/opportunity for their movement.

I then seized the above noted One Truck Dala Body having registration number WB/59C/0167 loaded with 19 (nineteen) numbers of big size Buffalos of Black in Color. under proper seizure list and arrested the above noted accused person namely Md. Hussain (40) S/O Lt. Md. Abdul Matib of Vill- Chocha, P.O- Gangar Ghosh, P.S- Baisi, Dist- Purnia (Bihar) under proper memo of arrest and observing all the formalities of arrest for possessing and transporting the Cattle (Buffalo) which is reasonably belived to be stolen property and for causing unnecessary pain and suffering to the Cattle (Buffalo). The search and seizure made in between 01.15 hrs and 02.15 hrs. on 24.04.2023.

Therefore, I request you that a specific case under proper section of law may kindly be Initiated against the above noted arrested accused person namely Md. Hussain (40) S/O Lt. Md. Abdul Matib of Vill- Chocha, P.O- Gangar Ghosh, P.S- Baisi, Dist- Purnia (Bihar) and arrange for its investigation.
