With due respect and humble submission, I SI-Pradeep Diyali of New Jalpaiguri PS, Siliguri Police Commissionerate lodge this written complaint against the Face book ID profile named as Akash using mobile no.-7908489866 and Avijit Roy using mobile no.- 9732097210 to the effect that today on 24.04.2023 while using Face book that the accused person using the above mentioned Face book ID update a post at Face book regarding Rape & Murder of the minor girl namely Doli Roy in Kaliaganj District-Uttar Dinajpur, posted at Face book by the Account holder namely Akash state that "KALIAGANJ ER MALGOAN PANCHAYATER GANGUWA GRAMER NABALIKA MER GANA DHARSHAN AWAM HATYA....." and the next post updated by the account holder namely Avijit Roy may disturb the Public Tranquillity and provoking the Rajbanshi Community as well as other community with the intention to cause riot and the post update by Avijit Roy state as "RAJBANSHI HATYA WA DHARSAN KARE KHUN KARAR NAYA BICHAR AMAR MONE HAI, KEW WA KONO PARTY AMADER SAHAYTA KORBE NA. JODI AMARA NIJEDER MADHEAY JATI, DHARMA MATIR SACHETABOD AMADER MADHEYA NA ASE, AWAM SATARK NA HAI WA PRATIBAD KARTE NA PARI....."

All mentioned posts wantonly giving provocation to the Rajbanshi community as well as other community and also intent to cause riot in such intentional that may disrupt peace and tranquillity of the area and such kind of post may prompting enmity between the class and also may disrupt Law and Order situation in the area. Such kind of post provoke with intend to cause riot and it is intentional insult intend to provoke breach of peace by making statements which would create and promote enmity, hatred or ill will between different racial, class, religion, hatred, language or regional groups or casts or communities.

Therefore I, request you to kindly a specific case may kindly be started under proper section of Law against the above mentioned Face book ID profile named as Akash using mobile no.- 7908489866 and Avijit Roy using mobile no.- 9732097210 holder and arranged for its investigation.
