I **SRI BASUDEB GHOSH** [Aadhar Card No 8046 4899 9021] S /o late **Debendra Nath Ghosh**, resident of Village- Thiknikata, Post Office Sushruta Nagar, P.S.- Matigara, Dist.- Darjeeling West Bengal -734012 would like to inform your office that:-

That by virtue of registered deed of Sale Vide Document no. 2792 for the year of 1998, registered at the office of ADSR Siliguri, I am the owner of the land measuring 1.55 acre which is recorded in L.R. Khatian no.259, in respect to R.S. Plot No.72, corresponding to L.R. Plot No. 178- area measuring 108.5 decimals and in R.S. Plot No. 48, corresponding to L.R. Plot No.- 180- area measuring 46.5 decimals, I.e. situated in Mouza - KAWAKHARI, JL. No. 72, Pargana- Patharghata, Touzi No. 91 within P.S.- Matigara, Dist- Darjeeling, West Bengal.

Further more I would like to lodge a complaint against 1] **Sri Arjun Roy**, s/o Fatak Roy; 2] **Sri Hari Roy**, s/o Sri Arjun Roy and 3] **Smt. Haimanti Roy**, w/o Sri Arjun Roy all being a resident of Kawakhari, Medical More, Post Office Sushruta Nagar, P.S.- Matigara, Dist.- Darjeeling West Bengal -734012 **who along with their antisocial land brokers and associates are trying to take possession of my aforementioned land illegally and forcefully.**

This is in regards to that, during a random visit of my property on 19th April - 23, I noticed that the above stated people were engaged in cutting down two of my matured Kadam trees which has the current market value of approximately Rs 50,000/- (Fifty thousand Rupees ) only and were digging on my land for wall drain and destroying the demarcation area. As such, when I expressed my objection to prevent the said activities, they responded with violent action, as well as they started physically mistreating me. They pushed me on to the ground, destroyed and take in away me of my gold chain and my wallet having approx. Rs.10, 000/-cash (Ten Thousand Rupees) only. **They have shown a very violent and life threatening attitude against myself and warned me to never step foot on the premises and threatened to take my life.** As the situation was uncontrollable, I left the site for further legal action.

Therefore it is my humble request to you to kindly take necessary action against the above mentioned persons and his associates, as early as possible and save me and my family from any harm.
