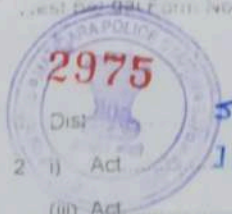

Respected Sir,

With due respect, I, **Sri Jayanta Chakraborty**, Son of Late Prafulla Chakraborty, residing at Kawakhari, Medical More, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling-734012 (W.B.), beg to state as follows:-

- 1) That my uncle Tushar Kanti Bhattacharjee has purchased a piece of land measuring about 5 Kathas, recorded in Khatian No. 2/2 corresponding to R.S. Khatian No. 149 & 150 corresponding to present Khatian No. 354, Plot No. 19, J.L. No. 19, under Mouza Thiknikata, P.S. Matigara, Dist. Darjeeling by virtue of a registered deed of sale being no. 5358 for the year of 1991 which was executed by one Jhantu Paul on 26.06.1991 and was registered in the office of the Sub-Registrar at Siliguri.
- 2) That said Tushar Kanti Bhattacharjee has also been recorded in the Record of Rights being Khatian No. 354 and he has also converted the said land from Agricultural Land to the Non-Agricultural Land.
- 3) That said Tushar Kanti Bhattacharjee constructed a tin shed pucca structure on the said land consisting 3 rooms, one barandha, one kitchen and one latrine and bathroom and started to reside thereon with his other family members.
- 4) That the said Tushar Kanti Bhattacharjee has been working at Gujrat and he has given me permission to live his said house with my other family members and since last 6 years, I along with my other family members have been living at the said house as caretaker and used to visit the said house and to stay there from time to time.

- 5) That on 27.04.2023 at about 2:15 p.m., one **Manoj Gupta, Sumi Gupta**, Wife of **Manoj Gupta, Dhananjay Roy, Puja Gupta, Gourav Kundu**, of Matigara Bazar, P.S. Matigara, Dist. Darjeeling and one **Gobinda Roy and Manisha Roy** (Advocates of Siliguri Bar Association) of Debidanga, Champasari, Pradhan Nagar, Siliguri, Dist. Darjeeling along with some antisocial forcibly entered into our house and they demolished our house.
- 6) That thereafter, when I raised protest, said **Manoj Gupta, Sumi Gupta, Dhananjay Roy, Puja Gupta, Gourav Kundu, Gobinda Roy and Manisha Roy** assaulted me physically with bamboo sticks and pushed me on the ground and tried to kill me by strangulating and kicked me on my body and I sustained injury and seeing the same, when my wife **Shila Chakraborty** and daughter **Anindita Chakraborty** tried to rescue me from the hands of the above named persons, they also outraged the modesty of my wife and daughter and also snatched cash of Rs.1,50,000/- only which was taken as loan from Bandhan Bank and also taken away golden ornaments worth about Rs.1,10,000/- only.
- 7) That the above named persons also destroyed all household articles, furniture etc. and now we have accommodation to stay.

So, I therefore, request you to investigate the matter and to take necessary legal action against the said **Manoj Gupta, Sumi Gupta, Dhananjay Roy, Puja Gupta, Gourav Kundu, Gobinda Roy and Manisha Roy** and others according to law and also to take necessary measures for our safety and security. And for this kindness, I shall much oblige to you.
