Sir,

I PSI (AB) Bipul Barman of Jalpaimore TG, SPC beg to lodge a written complaint that on 27.04.2023 around 18.10 hrs, I have received information that one Toto vehicle without any registered number are stationed at Major Road Burdwan Road Jalpaimore in such a way blocking the free flow of traffic and causing hindrance to the general public and other vehicles.

Accordingly, I PSI (AB) Bipul Barman along with ASI Dhiraj Chhetri and forces had been to the spot Jalpaimore, Siliguri around 18.20 hrs and found the above noted Toto vehicle along with driver had been stationed in such a manner disrupting the free flow of traffic causing hindrance and danger to the general public and other plying vehicles. On being asked he disclosed his name as Kanchan Chowdhury (30 Yrs), S/O- Surya Kanta Chowdhury of Adarsha Nagar, Jhankar More ,PO- Siliguri Bazaar,PS- Siliguri, Dist- Darjeeling, Phone No-9832693145.

Further on being asked him to produce relevant document in support of his claim of plying Toto on Major Road, but he failed to produce the same. Hence, he committed the cognizable offence disturbing the free flow of vehicular traffic and endangering the life and free movement of public in general. As such I arrested them U/S 41 Cr PC after preparing proper arrest memos and briefing him about the ground of his arrest in proper way. Therefore, I also seized the Toto from his respective possession after preparing proper seizure list in presence of local witness and duly arrested by them and took into custody. Provided them copies of seizure list of his respective Toto which was kept in Jalpaimore TG premises.

Hence, I would, therefore request you to kindly start a specific case under proper section of law against all the above accused Toto drivers and obliged.
