Respected Sir/Madam,

I Meeta Sharma resident of South Babupara Siliguri  
Seeking for your help to look into a dog Kennel  
(Jennelle's Pet Kennel) owner Priyanka Majumdar  
who is running a kennel irresponsibly.

On 6th April '2023 I took my two dogs to admit  
in her kennel as I was going out of station for work  
purpose. They were physically fit and healthy with  
no health issue but when I returned to Siliguri  
and asked for my pet discharge on 15th April '2023  
she showed her personal work and delayed to  
16th April. On stated date I went to the kennel to  
bring them back home but I saw my pets were  
in terrible condition. They were sick, dirty and  
was discomfortable to walk. Since 16th April one of  
the dog (Poppy) was seriously ill and other one  
was eye injured. They were not eating and when I  
informed her about it, she completely ignored. My  
dog got serious illness and died due to her negligency  
and unhygienic surrounding. My dogs were admitted for  
10 days and in this 10 days she did not update anything  
about my dogs. I asked her for video call and she  
ignored it too. Whenever I called her she was not  
present in the kennel and always made some  
excuses.

They have committed mal practice, unfair

P.T.O

trade practice. Deficiency in providing the services that they mentioned in their kennel forum and sheer act of negligence led death of my dog.

With due respect I request the police authorities to look into the matter and initiate necessary legal action against the owner of the dog kennel and I seek to check there CCTV footage so that we can check out the environment where we are leaving our pet for boarding. And also look into the ingredients of Prevention of Cruelty to Animal Act 1960.
