Sub: - F.I.R

In producing herewith three (03) arrested accused person namely (i) Sandhya Sah (32) w/o Harkeshwar Sah of Old Matigara Road, PS Pradhan Nagar, Dist. Darjeeling (ii) Leela Chowdhary (60) w/o Birendra Chowdhary of Old Matigara Road, PS Pradhan Nagar, Dist. Darjeeling (iii) Bubai Ghosh @ Chotan s/o Mahadev Ghosh of Tikiapara, PS Siliguri, Dist. Darjeeling with the following articles under proper seizure as per seizure list;

- a) One Blue coloured Bag containing 12 Kgs 894 grams of Ganja recovered and seized from the joint possession of Leela Chowdhary, Sandhya Sah and Bubai Ghosh @ Chotan marked as "Exhibit- A".
- b) 25 Grams of Ganja taken out as sample for examination from Exhibit A and marked as Exhibit A-1.
- c) One Check Coloured striped bag containing 13 Kgs 356 Grams of Ganja recovered and seized from the joint possession of Leela Chowdhary, Sandhya Sah and Bubai Ghosh @ Chotan marked as "Exhibit- B".
- d) 25 Grams of Ganja taken out as sample for examination from Exhibit B and marked as Exhibit B-1.

(Total of 26.250 Grams)

I, SI Abhishek Theengh (32), S/O- Suchandra Kumar Theengh of Pradhan Nagar Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused persons namely (i) Sandhya Sah (32) w/o Harkeshwar Sah of Old Matigara Road, PS Pradhan Nagar, Dist. Darjeeling (ii) Leela Chowdhary (60) w/o Birendra Chowdhary of Old Matigara Road, PS Pradhan Nagar, Dist. Darjeeling (iii) Bubai Ghosh @ Chotan s/o Mahadev Ghosh of Tikiapara, PS Siliguri, Dist. Darjeeling to the effect that on 11.05.2023 at about 13.15 hrs. I received a specific source input that three persons possessing huge quantity of Ganja was standing at near SJDA Gate, Siliguri Junction, under Pradhan Nagar PS to sell the same to their designed local customers. The matter was diarized in Pradhan Nagar PS GDE No. 618/23 Dt. 11.05.2023. Subsequently, I informed the matter to you on written and with your prior permission and being directed, myself along with ASI Manoj Kumar Roy, LC/1334 Sabita Sarki, CV-992 Jagadish Biswas, CV-646 Baban Das, CV-242 Rakesh Mangar all of Pradhan Nagar PS, SPC, and after being contacted to the Videographer Bapan Ghosh (32) S/O Lt. Rabhi Ghosh of Jagannathpur, PO Bidhannagar, PS Phansidewa, Dist. Darjeeling and with investigation kit left for SJDA Gate, Siliguri junction under Pradhan Nagar PS by Govt. vehicle to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No. 620/23 Dt. 11.05.2023 and M.C.C No- 1245 Date- 11.05.2023.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

At 13.45 hrs, after reaching at near SJDA Gate, Siliguri junction under Pradhan Nagar, I requested two persons as independent witness by notice namely (1) Ashok Kumar (45) s/o Lt. Bindeswari Prasad Singh of Khagaria, PS Choutha, Dist. Khagaria, Bihar A/P Coolie Para, Dharam Nagar, PS Pradhan Nagar, Dist. Darjeeling and (2) Raj Kishore Sah (32) s/o Lt. Sri Ram Sah of Coolie Para, Ward No. 01, PS. Pradhan Nagar, Dist. Darjeeling and made them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed and thereafter being pointed by my source detained 03 (Three) person mentioned above who was standing at near SJDA Gate, Siliguri junction under Pradhan Nagar PS. They had carried one blue colour Bag and one check coloured stripe bag under their possession.

Thereafter, we disclosed our identity and the information in hand and stated them that they as well as the bag under their possession will be searched for the purpose. And, I gave them option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which they agreed to be searched in presence of any one of the above.

I also offered the independent witnesses and the accused persons to search our Police Party as per provisions but they did not search the police party. Consequently, I informed the matter to you and as per your kind order, I informed to Shri Moksedur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused persons suspected to be possessed Ganja illegally and requested him to come at near SJDA Gate, Siliguri junction under Pradhan Nagar PS to remain present and to supervise the search and seizure.

Accordingly at 14.20 hrs Shri Moksedur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC arrived at the spot at near SJDA Gate, Siliguri junction under Pradhan Nagar PS as Special Executive Magistrate, SPC and in presence of two independent witnesses and hereafter I searched the detained persons and both the lady accused persons was searched by LC/1334 Sabita Sarki of Pradhan Nagar PS, following all formalities, keeping their decency and recovered the above noted articles from the joint consious possession of the accused persons namely Leela Chowdhary, Sandhya Sah and Bubai Ghosh @ Chotan.

Further, on demand in presence of Shri Moksedur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC, the detained persons namely Leela Chowdhary, Sandhya Sah and Bubai Ghosh @ Chotan, on being asked, failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of Ganja.

Thereafter, I seized containing 12 Kgs 894 grams of Ganja from the joint conscious possession of Leela Chowdhary, Sandhya Sah and Bubai Ghosh @ Chotan and marked as "Exhibit- A" which was kept inside One Blue coloured Bag and 13 Kgs 356 Grams of Ganja from the joint conscious possession of Leela Chowdhary, Sandhya Sah and Bubai Ghosh @ Chotan and marked as "Exhibit- B" which was kept inside one Check Coloured striped bag at the spot at near SJDA Gate, Siliguri junction under Pradhan Nagar PS under proper seizure list in presence of independent witnesses and Shri Moksedur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC, obtaining their signature and being acknowledged by the accused persons.

Subsequently, I labelled and sealed the seized articles in presence of Shri Moksedur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC and independent witnesses and the accused persons namely Leela Chowdhary, Sandhya Sah and Bubai Ghosh @ Chotan. The whole process of seizure was made in between 14.30 hrs to 15.55 hrs with the videography.

Being further asked, the apprehended person namely Leela Chowdhary, Sandhya Sah and Bubai Ghosh @ Chotan admitted in presence of Shri Moksedur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate and other independent witnesses that they have procured Ganja clandestinely for the purpose of selling the same in high rate to their designed local customers for their personal gain by illegal means. On further being asked, they also disclosed that they have been dealing in this business of procuring and selling of Ganja based drugs illegally for last few months for their wrongful gain mainly selling chiefly in Siliguri and Cooch Behar and its adjacent areas.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely Leela Chowdhary, Sandhya Sah and Bubai Ghosh @ Chotan is involved in procuring and selling Ganja based drugs illegally contravening the norms of NDPS Act. -

Then, I arrested the above noted accused person namely Leela Chowdhary, Sandhya Sah and Bubai Ghosh @ Chotan after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest respectively.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely (i) Sandhya Sah (32) w/o Harkeshwar Sah of Old Matigara Road, PS Pradhan Nagar, Dist. Darjeeling (ii) Leela Chowdhary (60) w/o Birendra Chowdhary of Old Matigara Road, PS Pradhan Nagar, Dist. Darjeeling (iii) Bubai Ghosh @ Chotan s/o Mahadev Ghosh of Tikiapara, PS Siliguri, Dist. Darjeeling and arrange for its investigation.
