I Abhishek shaw, the above noted complainant
beg to inform you that I am the staff of Sri Ashit
shaw (39) S/O Sri Ashok shaw, of South Ambedkar
colony (Near Diesel shed) ward No. 1 SMC, P.O & P.S -
Pradhan Nagar, Distt - Dajepoly and we used to sell
ice-creams etc, on our mobile cart at the city as
name and style M/s Abhishek Kulti, on dt. 11-05-23
at about 09:30 pm, when I along with my co-stuff
namely, Md. Sabir Ansari @ Md. Sabir (21) S/O Md.
Kayum Ansari, returned to our employer residence where
we also reside, at South Ambedkar colony, at that
time, our rival ice-cream vendors namely (1) Sohan
Sahani S/O Lt. Bhola Sahani & his 02 (two) sons namely
(2) Chhotu Sahani & (3) Umesh Sahani, all are of
Thokkar (Near Mount Point Carmel school), P.S - Matigara
& their associate namely (4) Pawan Sah of Gwalopathy
and said Sohan Sahani's son-in-law namely,
(5) Hira Sahani of Khepnail Bazar, entered into our residence
at South Ambedkar colony and brutally, beaten me
& my co-stuff namely Md. Sabir Ansari @ Md. Sabir
brutally with fist & blows and injured us grievously
and stolen away the silver chain (54gms) from
the neck of M.D. Sabir @ Md. Sabir Ansari.

Sir, they have also threatened us for dire consequences
if we will not leave Siliguri. We both shifted
to Siliguri Distt. Hospital & treated ourselves here.
So, please take necessary action against the above
