I. I am Lt Col Hausriz Azmat, I am a medical officer in Indian Army posted at 4033 Fd Hosp. I am residing in Sukna Salbari Sukna in civil area.

I have 2 hired maids from civil named Roshan Khatun and Noor Bano. Sir the maids have been working in our house since past 2 months.

Today on 12 May 2023 at approx 0830 hrs I had a verbal spat after which me and my husband Lt Col Hausriz Singh who is also working in Indian Army left for our work place (Sukna Cantt).

When we returned home in afternoon after office I found my front door closed. On entering the house I found my house littered with garbage. My clothes were all taken out of my cupboard and were thrown along with the garbage on the floor. My bed was also littered and was made wet by throwing some liquid on bed. On entering the other side of my house I found that my dog was lying on the floor lifeless. On checking upon the dog I found that he had been it was having blue tongue and was not breathing. I

found that it has been <sup>2</sup> lying dead over there for a long time. I asked my mother who resides with me also as to what happened. My mother told me that the maid Roshan Khatun had told my mother that 'Madam ne aaj mujhe aisa kaha ki Bhagwan tumhare sath bli wohi karenge jotum mere sath karogi and after that she started ~~to~~ crying and told my mother that she will not do any work and that madam should have thought about saying all this to me. after that the maid left my house at 1300 hrs.

Sir I have a very strong suspicion on my maids Roshan Khatun and Noor bano who together killed my dog and disturbed the contents of my house.

Also I want to state that only my clothes had been thrown on floor. My husband's and son's clothes or <sup>NO</sup> belongings had not been touched. It seems to me an act of revenge by my maid Roshan Khatun and Noor Bano. They are both residents of a nearby locality Nai Basti. Her mobile number is 8927734814.

I request that my case be registered and strict legal action may be taken against the perpetrators who disturbed my peace of mind while I was on duty. This act of vindiction was done while I was not at my home and also it was a great danger as my mother

who was alone at the time this incident happened.  
I request that a post mortem examination be carried out on my deceased pet and ~~the~~ also the food my maid had prepared for the dog be examined for any toxic substance.

I request that strict action be taken against Rochan Khatur and Noor Banu. I had not enquired about the background of these maids and had hired them without police verification.
