Thereafter, as per requirements I have placed orders with said Lalit Kumar Banthia for purchasing Bitumin and as per orders he has supplied the materials vide different firms namely 1) Jai Mata Di Enterprise, 2) Vinayak Bituminions, 3) Shubham Petro Products, 4) Jai Jalaram Sales Corporation, 5) Globe Bitumin, 6) Satyam Enterprise 7) Mohan Infrarealty Pvt Ltd.

- 1. That payments were made accordingly as per the invoices.
- 2. That in 4.12.2020 I received a letter from Md. Sayeb Alam Assistant Commissioner, Bereau of Investigation, Noth Bengal, Head Quarters, S.G.S.T. and in the said letter it was alleged that the transactions between Jai Mata Di Enterprise having GSTIN: 10ARGPT2264A1ZC amounting to Rs. 39,87,463.53/-, Vinayak Bituminious having GSTIN: 19CNAPD4980K1ZQ amounting to Rs. 1,11,444.74/- are inadmissible. Hence, I have to reverse the inadmissible ITC along with interest and penalty u/s 74 (5) of the CGST & WBGST Act of 2017. After receiving such letter from the GST department I tried contacting with the said Lalit Kumar Banthia but I received no positive approach from him.
- 3. That thereafter on 06.12.2022 I received demand notice from one Mr. Suvranil Saha for Rs. 78,95,250/- who represented himself as Advocate of M/s Global Bitumin. The said notice was suitably replied by my Advocate namely Taniya Roy on 20.01.2023.
- 4. That from the entire transaction what I could figure out is that said Lalit Kumar Banthia falsely impersonating himself as proprietors of several concerns and supplied Bitumins to several companies through several entities whereas some of the firms were fake and said Lalit Kumar Banthia dishonestly received and

To my utter surprise it is also a fact that the said notice served by Mr. Suvranii Saha, Advocate did not bear name of the proprietor/proprietors of M/s Global Bitumin and I believe that the said notice was also served as per instructions of said Lalit Kumar Banthia. There is a substantial delay in lodging the complaint because after receiving the notice from the GST department there were rounds of talks held in between me and the said Lalit Kumar Banthia and he informed that the inadmissible ITC shall be paid by him to the department but without doing the same he has served lawyers demand notice to me.

It is pertinent to mention here that same kind of fraudulent act was done by said Lalit Kumar Banthia with other persons also and they have also received notices from the GST department.

In this conspiracy his brother-in-law Mitesh Jain proprietor of Jai Jalaram Sales Corporation, place of business 213, Sarat Bose Road, Kolkata - 700029, Mobile: 82408-42605/ 99032-46470 is also involved actively.

5. That all the payments made to the entities supplying bitumins including the firms where GST amounts have been misappropriated by Lalit Kumar Banthia were made by my bank account maintained with Axis Bank Limited, S.F. Road Branch under this Police Station.
