I Maimun Nissa Khatun w/o.  
Lt. Md. Salim residing at Vivekananda Nagar, ward no-7  
Kaila Dipo, would like to inform you that today  
at about 6.20 pm when I was passing beside the  
Madrasa School some group of persons was fighting  
each other, suddenly they all throwing stones  
towards me, I was very much afraid I was trying  
to stop them but they did not stop at that  
time. I am 50 years old lady, after some  
time told to them they were abusing me  
and continuing to throw stones, beer bottles towards  
me and my head was hurt by two  
stones and broken piece of beer bottles.  
I got brutally injured and fell down on the  
road but they still threaten me to kill  
if I will complain any police authority.  
after that I was taken to the Siliguri  
district hospital and two stitches on my  
head by the doctor, when I was not  
involved in their fighting and just passing by  
for buying tea only. There are several  
persons ~~but~~ i.e. i) Najia Khatun D/o-  
Md. Abdul Samad ii) Sweety w/o Md. Salim,  
iii) Md. Salauddin S/o - Md. Faiz (iv) Rukana  
Khatun w/o - Salauddin. v) Sabana Khatun w/o -  
Md. Nazim @ Pappu were there, and they still  
threatening me.
