Darjeeling would like to inform you that today i.e. on 09/05/2022 at about 02.00 p.m. some neighbours of my locality namely 1. Ranjit Routh, 2. Chotka Routh, both of them are S/o. Anopi Routh 3. Suroj Routh, S/o. Ashok Routh, 4. Krishna Routh, S/o. Ashok Routh, 5. Banarasi Routh, S/o. Not Known, 6. Rahul Routh, 7. Akash Routh, 8. Pinki Routh, 9. Koki Routh, 10. Laxmi Routh, 11. Renu Routh, 12. Sri Snjay Routh, 13. Sri Guddu Routh, 14. Smt. Shanti Routh, 15. Poonam Routh, 16. Rekha Routh, 17. Madhu Routh, 18. Putul Routh all of them are resident of same locality, without any reasons they all of them without any reasons cae in front of my house with some deadly weapons and after coming in front of my house they all of them started abused me and my family members and when I and my family members namely Baby Routh, Chandni Routh, Ashok Routh, Sonu Routh tred to protested the same at that time they all of them with help of Rod and others deadly weapons they all of them attacked upon me and my above noted family members with the inetention to kill us and due to assaulted by them I and my abovbe noted family members sustained multiple injuries on our whole body and due to help by other local people we taken to Siliguri Sadar Hospital for teatment and at the time of the aforesaid incident the above noted male persons intentionally touched the body parts of the female persons and also outraged the modesty of female members during that time the above noted persons also threatened me and my family mebers with dire consequences and told me that if I or my family members lodged any complaint against him then they will kill us so, no other alternative way with the help of my well wishers I lodged this complaint against the above persons before you.

Therefore, I request you be pleased to drawn your kind attention in respect of my above noted written complaint and also be pleased to save me and my family members from their hands as early as possible.
