Sir,

In producing herewith five (05) arrested accused persons namely (1) Sk. Ekramul(M/24), S/O- SK. Ispak of Sahapur, Baharal, PS. Rotua, Dist. Malda, (2) Krishna Tamang (M/22), S/O- Lt. Birbal Tamang of Jalpaimore, Natun Para ,W/No - 05, PS. Siliguri, Dist. Darjeeling (3) Palash Mandal (M/28), S/O- Lt. Pujan Mandal of Dabgram, Near Electricity Office, W/No - 23, PS. Siliguri, Dist. Darjeeling, (4) Bishal Routh (M/20), S/O- Lt. Birju Routh of Mazdoor Colony, Tikiya Para ,W/No - 28, PS. Siliguri, Dist. Darjeeling and (5) Sanjay Biswas(26) S/O Manindra Biswas of Tikiya Para, Matangini Colony-II, W/No - 28, PS. Siliguri, Dist. Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron hammer measuring 20 inch (approx), from the possession of Sk. Ekramul which was kept on his hand.
- (2) One metal made Rambo Knife measuring 10 inch (approx) including wooden handle from the possession of Krishna Tamang which was kept concealed on his back side,
- (3) One metal made knife measuring about 14 inch (approx) including wooden butt from the possession of Palash Mandal which was kept on his right hand,
- (4) One iron claw bar measuring 17 inch (approx), from the possession of Bishal Routh which was kept on his hand
- (5) One iron made Khukri measuring 18 inch (approx) including wooden butt being the metal portion kept inside a wooden cover from the possession of Sanjay Biswas which was carrying on his right hand,

I, ASI- Subir Sen S/O Lt Sachindra Nath Sen of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others viz. Biki Sahani, Badal, Promod Sahani, Nandu and others to the effect that today on 11.05.2023 at 00.35 hrs received a sources information that 13/14 youths have assembled at Back side Indoor Stadium near Old CBI Court with a view to commit dacoity in a house at Deshbandhu Para area. The fact was diarized in GD vide Siliguri PS GDE No- 625, dated 11.05.2023. Subsequently after sharing the information with I/C Siliguri PS and as per his direction, myself along with ASI- Debasish Das, CV/622 Ramanath Barman and CV/283 Prasenjit Dey, left for the place to work out the information. On way I contact ASI Bikash Roy who was performing k-21 Van to accompany us to work-out the information. We reached at Indoor Stadium at 01.00 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from Indoor Stadium and seeing police personnel they tried to flee away from the spot but on hot chase we managed to apprehend above noted five (05) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Deshbandhu Para area with the leadership of Palash Mandal.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.35 hrs to 02.15 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

Accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Deshbandhu Para area. It is also revealed from them that (1) Biki Sahani, (2) Badal, (3) Promod Sahani, (4) Nandu and some others have been assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Sk. Ekramul(M/24), S/O- SK. Ispak of Sahapur, Baharal, PS. Rotua, Dist. Malda, (2) Krishna Tamang (M/22), S/O- Lt. Birbal Tamang of Jalpaimore, Natun Para ,W/No - 05, PS. Siliguri, Dist. Darjeeling (3) Palash Mandal (M/28), S/O- Lt. Pujan Mandal of Dabgram, Near Electricity Office, W/No - 23, PS. Siliguri, Dist. Darjeeling, (4) Bishal Routh (M/20), S/O- Lt. Birju Routh of Mazdoor Colony, Tikiya Para ,W/No - 28, PS. Siliguri, Dist. Darjeeling and (5) Sanjay Biswas(26) S/O Manindra Biswas of Tikiya Para, Matangini Colony-II, W/No - 28, PS. Siliguri, Dist. Darjeeling, (6) Biki Sahani, (7) Badal, (8) Promod Sahani, (9) Nandu and others and arrange for its investigation.
