Bhaktinagar, Dist Jalpaiguri would like to inform you that today I was on my motor bike with my friend being my vehicle No WB74BL 6445 on Sukna, near S.I.T. College where my vehicle was on the way to Siliguri, one four wheeler Volkswagen Polo white colour being vehicle No. MH 09EU1846 hit came with excessive speed and hit my motor bike with a bang and my friend namey Rehana Khatoon received serious injury and at present she is hospitalized in ANANDALOK NURSING HOME, Sevoke Road Siliguri and now she is in ventilation fighting the last stage of her life and the bike is also totally damaged.

You are requested to take proper legal action against the owner of the vehicle at the earliest.
