I the undersigned Anil Kumar Mitruka, son of Late Brijmohan Mitruka, resident of 146, M. G. Road Siliguri like to state that my father late Shri Brijmohan Mitruka had expired on 25/04/2023. I along with my family members were busy in performing his last rituals completed on 11/05/2023.

Sir, today on 13/5/20123 at about 7:00 a.m. in the morning when I woke up and wanted to go outside from my residence for walking, I found that someone has kept the sand in huge quantity in my godown which I have arranged to keep my business goods temporarily by vacating the said godown so as to perform the last rituals of my father by using the said godown. It is to be noted that i also found that two CCTV cameras have also been broken by the miscreants or the said person.

And on query about the storage of sand in my godown, to my younger brother Shri Bimal Kumar Mitruka as I wanted to clarify the matter then he excited and attack on me and assaulted me physically and abused me in slang language and threatened me with dire consequences by saying he would do as per his choice and desires. He committed the offence punishable under the law and broke the CCTV camera to store the sand in my godown to grab my property illegally and wrongfully.

So I request you sir to take a note of the incident in your record and do the needful
