you that MISS KABITA BARMAN, aged about 17
years, is my younger daughter, who reside with
us at my above mentioned residential address.

On 02.02.2023, two people namely 1. AMIT SAHA, S/o.
Ajay Saha and 2. DIPIKA SAHA, w/o. Amit Saha, resident
of Vill. Khogdoibari, Ashugash, visited our house and
offered us that they will provide a private job to
my aforesaid daughter at Nursing. As we are
extremely poor and going through financial
distress, finding no other option, accept their
proposal. They promised and assured that they
shall provide a satisfying salary to my daughter
and they shall arrange lodging for my daughter.
On 04.02.2023 my daughter left with them but
thereafter my daughter never came back to my
house. I tried to reach her through mobile phone
several times but it is switched off. I contacted
said Dipika Saha and asked whereabouts of my daughter
but she replied that my daughter is absolutely fine.
On 30.04.2023 I visited their house in search of my
daughter but I could not find her. They are saying that
they no nothing about her. I think they might have
kidnapped and concealed her in some secret place
for their illicit gain.

I therefore, request you to kindly trace out my
daughter anyhow as she might be in danger.
