I Chandan Choudhary s/o Ram Pratap Choudhary r/o Kholai Baktari P.O & P.S Matigara dist; Darjeeling would like to lodge this F.I.R in your ps regarding the fact and brutal assault inflicted on me and my aged mother namely Putul Devi Choudhary w/o Ram Pratap Choudhary r/o Kholai Baktari P.O & P.S Matigara dist; Darjeeling by Kalu Sahani s/o not known r/o Kholai Baktari P.O & P.S Matigara dist; Darjeeling, laddu Sahani S/o not known r/o do. and Chotu Sahani S/o not known r/o do.that today i.e., 04/05/2023 at around 2:30 pm when I was going to my house from market at that time when I crossed the house of the above mentioned persons then at that time they used slang and abusive languages towards me and my family members and threatened me for dire consequences but when I politely told them not to do the same then at that time they became even more aggressive and ferocious and assaulted me with fist and blows and also used sharp cutting weapon to inflict injury on me and as a result of which my lips got slit up and somehow it didn't impacted over my neck otherwise I would not have been able to survive and they also brutally punched me on my face it is very important to highlight the fact that the above mentioned persons on a daily basis sells illicit liquor from their house, and they are also polluting the society with their illegal and unlawful works. It is pertinent to mention here that listening to my painful cries my above mentioned mother also came to the spot for my rescue but she also met the same fate and got brutally assaulted by them they also tried to disrobe my mother and snatched away the chain from her neck she was even slapped and kicked multiple times and as result of which we both had to take medical attention and treatment in Siliguri district hospital. it is very hard for us to go to our house as they have given us life threat that they are people with high level access and they will take our life if we go into our locality. so finding no way out I am lodging this complaint against the above mentioned persons so that proper legal action is taken against them.
