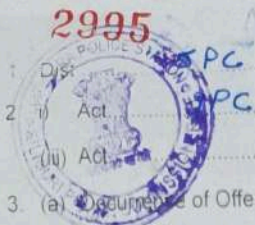

Sir,

In producing herewith 05 (five) arrested accused persons namely (i) Basarul Shekh (28), S/O- Abu Ali Shekh of Sutki Godown, PO+PS-Matigara, Dist.- Darjeeling (Not verified) (ii) Chotu Das (29), S/O- Lt. Saleke Prasad Das of Rajibnagar Colony, PO+PS-Pradhannagar, Dist-Darjeeling (Not verified) (iii) Md. Kismuddin (22), S/O- Md. Kamal of Suknta Pally Gas Godown PO+PS- Matigara, Dist.- Darjeeling (Not verified) (iv) Joynal Abedin Khan (20) @ botol S/O Mehaborj Khan of Panchkolguri Mokbul Busty, PO- Nemai ,PS-Matigara, Dist-Darjeeling (Not verified) and (v) Md. Sajat Ali (24) S/O Md. Safigul Panchkolguri Mokbul Busty, PO- Nemai ,PS-Matigara, Dist-Darjeeling (Not verified) arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made 'Knife' found from the possession of Basarul Shekh which was kept in his right hand.
- (2) One iron made 'Crowbar' found from the possession of Md. Kismuddin which was kept concealed at his back.
- (3) One iron made 'Bhojali' found from the possession of Md. Sajat Ali which was kept on his right hand.
- (4) One iron made Hasua' found from the possession of Joynal Abedin Khan @ botol which was kept on his right hand.

I, SI Agen Lepcha S/O Dup Tshering Lepcha of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Basarul Shekh (ii) Chotu Das (iii) Md. Kismuddin (iv) Joynal Abedin Khan @ botol (v) Md. Sajat Ali and others to the effect that today on 07/05/2023 at 01:15 hrs received a sources information that 10/14 youths have assembled at Chowrangi More Patiramajote under Matigara PS with a view to commit dacoity in a house at Patiramjote area. Subsequently, after sharing the information with my superiors and as per their direction, I along with SI Sajal Roy C/1053 Pores Rava, C/974 Mintu Sen, and CV/977 Ganesh Paswan all of Matigara PS, SPC, left for the place to work out the information. At about 01:30 hrs after reaching near Chowrangi More Patiramajote under Matigara PS I met my source and being pointed by the source we started walking towards Chowrangi More. At 01:40 hrs. we reached at Chowrangi More and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot. Seeing police personnel approaching towards them they tried to flee away but on hot chase we managed to apprehend above noted 05(five) accused persons along with seized articles as mentioned above. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation all the accused persons admitted that they had assembled there to commit dacoity in a house at Patiramote area.



I thereafter, seized the above noted deadly weapon under proper seizure list in presence of witnesses duly acknowledged by the accused persons. The whole seizure was made in between 02:35hrs to 03:20hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house of Patiramjote area. It is also revealed from them that some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of law against the above noted accused persons viz. (i) Basarul Shekh (28), S/O- Abu Ali Shekh of Sutki Godown, PO+PS-Matigara, Dist.- Darjeeling (Not verified) (ii) Chotu Das (29) , S/O- Lt. Saleke Prasad Das of Rajibnagar Colony, PO+PS-Pradhannagar, Dist-Darjeeling (Not verified) (iii) Md. Kismuddin (22), S/O- Md. Kamal of Suknta Pally Gas Godown PO+PS- Matigara, Dist.- Darjeeling (Not verified) (iv) Joynal Abedin Khan (20) @ botol S/O Mehabor Khan of Panchkolguri Mokbul Busty, PO- Nemaï ,PS-Matigara, Dist-Darjeeling (Not verified) and (v) Md. Sajat Ali (24) S/O Md. Safigul Panchkolguri Mokbul Busty, PO- Nemaï ,PS-Matigara, Dist-Darjeeling (Not verified) and others and arrange for its investigation.
