With due regards I, Prabha Picoari Yolmo, Advocate
of Siliguri Court and a resident of Bharu Nagan
Near Hotel Alishan, P.O. Sevoke Road, P.S. Bhaktinagar,
Dist. Jalpaiguri humbly submit the following
for ^{your} prompt and appropriate legal actions please:-

1. That on the night of 19-04-2023 when my dog
named BLACKY who was sleeping just in front of
my house and lodge was mercilessly trampled by
driving a ^{car} by the guard named Sahabuddin of the Alishan
hotel at around 8.30 pm. When I charged the
guard he denied and ran off from there. ~~There~~
and then. After a few moments when I left
from there I warned him if anything happens
to my dog I would report him to the police
and then returned back to my apartment.
The next day when I went ^{to} feed my dogs
again I found BLACKY missing then the nearby
shop guy came running and informed me
that BLACKY had been killed the same day
at night around 9.55 pm. I got few footages
from the managers office ^{the next day} Today when I went
again in the evening around 8.00 pm to see
the main footage of the day he was attacked.
The first time it was clearly visible that Sahabuddin

had intentionally and mercilessly drove the car on my dog and killed him. As soon as we saw this in the footage the manager of Alisham Hotel switched off the screen and started shouting and denied to show us the footages further as it was clearly visible that the guard named Sahabuddin ^{had} run off the vehicle above my dog.

They just came out of their office and ran off from there as soon as we started going live on facebook. After great hue and cry we came to report this matter in your Police Station as we fear that they may tamper the CCTV footages in order to remove the evidence of the merciless killing of my dog.

I therefore humbly request your goodself to kindly lodge this complaint / FZR against the abovenamed guard named Sahabuddin and also the manager named Buntly who has been a partner in the crime of Alisham Hotel and prompt appropriate legal actions may kindly be taken against them and also the CCTV footages may be obtained and oblige us
