In producing herewith, the accused person namely (1) Dilip Sutradhar (49 yrs), S/O Late Anonta Sutradhar of Horirampur PS Shahzadpur Dist. Sirajganj Bangladesh along with the following articles under seizure: -

- i. One (1) Indian Aadhar Card no. 3988 3919 7045 in the name of Dilip Sutradhar C/O Ananda Sutradhar of Mandal Para VTC-Jalalkhali PO jalalkhali, Sub- District Krishnanagar -I Dist Nadia, West Bengal.
- ii. One (1) Indian Voter Identity Card no. XZF2458990 in the name of Dilip Sutradhar S/O Ananda Sutradhar of Haripurpara, Jalalkhali Kotwali Nadia.
- iii. One (1) Xerox copy of Passport no. BGD A02825489 in the name of Delip Sutradhar S/O Anonta Sutradhar of Horirampur, Shahzadpur Talgasi Sirajganj, issued by Peoples Republic of Bangladesh.

I SI Pradip Kr Singha of Ashighar OP under Bhaktinagar PS beg to lodge this written complaint against the above noted arrested accused person to the effect that today on 24.04.2023 at 13.55 hrs. I received a reliable source information that one Bangladeshi National namely Dilip Sutradhar comes in Indian with Passport & Visa. He also posseses some Indian documents like Aadhar Card & Voter Card illegally and he will come near Ashighar Sub- Registry office. I diarized the fact in G.D. vide Ashighar OP. G.D.E. No - 551 Dated - 24.04.2023 and informed the matter to O/C Ashighar OP. As per kind direction of O/C Ashighar OP myself along with ASI Sumit Baran Nath, ASI Krishna Ch Singha, C/376 Shayamal Choudhury, C/973 Kaushal Roy all of Ashighar OP left for Ashighar Sub- Registry office to verify the veracity of information. At 14.05 hrs we arrived near Ashighar Sub- Registry office. At around 15.15 hrs as indicated by my source myself along with my accompanying party apprehended the above noted accused person when he came at the spot. On being asked he disclosed his identify as noted above. On being further asked he also stated that he is a Bangladeshi National, enter India with Passport & Visa, He also prepared some fake Indian identity cards in his name viz. Aadhar card & Voter identity card. Accordingly, I searched him in presence of available witnesses and recovered the above articles, which I seized under proper seizure list as alamath of the case. I also arrested the above person u/s 41 Crpc issuing proper memo of arrest. The search, seizure and arrest were made in between 15.35 hrs to 16.15 hrs on 24.04.2023.

Under the above noted circumstances, I pray, a specific case against the above noted accused person may kindly be started under proper section of law and arrange for its investigation.
