He has been constantly Stalking my Daughter and sending her Obnoxious messages and Pictures to my daughter's email [sultanaparvin.736@gmail.com](mailto:sultanaparvin.736@gmail.com) via his Email Id: [action.ra3@gmail.com](mailto:action.ra3@gmail.com) on 4<sup>th</sup> April 2023 at 5:06 PM, 5<sup>th</sup> April 2023 5:36AM and on 17<sup>th</sup> April 2023. And in whatsapp using mobile number 8670333895 It seems like he is conspiring to tarnish my image. He has been threatening her with lots of messages saying she have taken money from him and asking her to settle the matter.

It is worth mentioning here that he is taking advantage of Information Technology to get her whatsapp messages and emails, and Her transactional messages from her bank. As on April 20 2023 07:17 PM he again emailed my daughter asking her to refrain from using her banking and threatening her from being arrested.

It has been a matter of concern that he has managed to contact her colleagues at work with the copy of her passport and asking about the the location my daughter.

He is constantly emailing her with all sorts of obnoxious pictures of him with some other Person, Which I have attached for your references.

He has been sending her Obnoxious picture with cryptic emails. Cropping her Images from my whatsapp status and posting it in his status. He has been causing breach of privacy using different fraudulent and fakes tactics. She has been forwarding me all the thats happening, and I have asked her to refrain from commenting anything.


All this incidents are creating mental pressure for my Daughter, due to which she is unable to concentrate in her daily routine.
