Respected Sir,

I, Mohammad Sadik, son of Mohammad Samim, resident of "JAISWAL COMPLEX", situated at Mouza - Kalkut, JL no. 44, Pargana - Patharghata, PS - Pradhan Nagar, Dist - Darjeeling, begs to inform you that I am at present working as a caretaker of the below schedule property of Shri. Vinod Kumar Jaiswal, son of Rajendra Prasad Jaiswal, r/o J4, 12 Civil Township, Sundargarh, Rourkela, P.O & PS - Raghunath Pali, Dist - Sundargarh, Orisha, Pin - 769004, namely "JAISWAL COMPLEX", recorded in LR kahtain no. 5655, corresponding to LR plot no. 159 and 307 situated at Mouza - Kalkut, JL no. 44, Pargana - Patharghata, PS - Pradhan Nagar, Dist - Darjeeling and the owner Shri. Vinod Kumar Jaiswal have duly constructed one storied tin shaded structure consisting of 5 shop rooms in the front side and 3 residential accommodation in the back side and there are four tenants in the four shop rooms and one family is residing in the residential accommodation area in the back side.

That suddenly today morning at about 11.20 a.m. 1) Sri. Ram Sakha Singh, son of Late Bhogi @ Bhugani Singh, 2) Sri. Ajit Kumar Singh @ Rangila, son of Sri. Ram Sakha Singh Sardar 3) Sri. Biswajit Singh @ Azad, son of Ram Sakha Singh Sardar and 4) Smt. Monika Singh, daughter in law of Sri. Ram Sakha Singh Sardar, came to the said property along with 40 to 50 more men and muscleman who are local goons of the locality and bring one bulldozer, iron rods, kukris and sharp weapons and thereafter they with intent to encroach the below schedule property used the bulldozer to demolish the tin shaded structure and seeing the same I rushed to them and raised objection to their illegal act, though they stopped the bulldozer but they became aggressive and furious and abused me with filthy languages and hit me with the iron rods for which I have sustained injuries and they all threatened me to leave the said place and also threatened that if I don't follow their order then I have to face dire consequences.

That they said that if I do not vacate the place and resist them from taking forcible possession of the said propriety then they will not hesitate to kill me.

That when I raised my strong objection with the help of our tenants and neighbors at that time they were compelled to leave the place but they again threatened me while leaving the place that if I do not vacate the place then they will not hesitated to kill me to take forcible possession of the land.

That I am a poor man working as a caretaker and this is my only source of income for my survival and I am very much fear full for my life and safety as this people are very ferocious and will not heisted to kill me to fulfill their illegal gain.

Sir, I am under constant fear for my life and this is my humble request to you that to take proper and strict legal action against this people.
