day. I pressed my hand on that link and a recharge

link opened where 20 rupees to be given to update
my payment status. I repeatedly tried to give that

20 rupees and Mr. Sagar Banerjee was in the call through
out the procedure for nearly 40 minutes and 1 pm

amounts and he repeatedly asked to download "Quick Support
'SMS Forwarder'" "RustDesk" and google chrome. I shared
my OTP, ATM card no, Bank Account no, YOU KNOW SBI
password in a mentally "diverted" condition. And by

this way an amount of 91352 from SBI Account and
26,222.43 - Punjab National Bank Account, totally frauded,

I shall be highly obliged if you kindly
take measure urgently so that I can take back
