Respected Sir,

I Suraj Mahato, s/o-Mahendra Mahato, resident of Ganga Nagar Natarpara main road, P.O & P.S. - Siliguri, Dist - Darjeeling Pin- 734005, would like to bring your kind attention to the following facts herein below:-

1) That on 23/04/2023, I along with 2(Two) other friends namely 1) Swail Jaiswal s/o - Suraj Prasad, resident of Jalpaiguri, Natarpara, Ranghat, P.O & P.S. - Siliguri, Dist - Darjeeling and 2) Frank Mahato s/o - (Aakash Kumar Mahato) s/o - Smit Mahato, resident of Barabahi Nagar road no - 5, Siliguri, P.S. - Siliguri Dist - Darjeeling went to Aishan Restaurant cum Bar situated at Barabahi Road, near Vishal Cinema Hall, Siliguri, Dist - Darjeeling to spend some quality time altogether in the evening.

2) That we and two my friends were enjoying on our own when one of my friend namely Swail Jaiswal went outside the restaurant to pee.

3) That at time passed on and our friend namely Sunil Jaiswal did not come back, then me and my friend Akash Kumar Mahato started searching for Sunil Jaiswal inside the hotel premises when one of the waiter of the aforesaid restaurant informed us that our friend Sunil Jaiswal is being beaten up by some unknown miscreants and as soon as we heard it we went running towards the spot to save our friend but as soon as we reached the spot our friend namely Sunil Jaiswal was not there and when we enquired about him from the persons who were present at the time of the scuffle they informed us that our friend was beaten up by some unknown miscreants and after they finished beating him up they took my friend Sunil Jaiswal

4) That as we could not find Sunil Jaiswal we tried contacting him over phone but was unable to reach him in response at first but after some time Akash Mahato somehow was able to connect him and he was informed by Sunil Jaiswal that some unknown persons have abducted him and dropped him near Chota Papri.

5) That after getting such information I along with Akash Mahato rushed towards Chhota Pappi but we could not find Sunil Jaiswal at night.

6) That on the very next day in the morning a phone call was received by one another friend namely Akash Mahato received from Sunil Jaiswal and he informed him that he is at unknown location and requested Akash Mahato to come pick him up.

7) That as soon as Akash Mahato got the information from Sunil Jaiswal he went to location to pick Sunil Jaiswal and after reaching there brought him back at Sunil Jaiswal house in an unconscious condition.

8) That after some time landlord of the Sunil Jaiswal informed me that he is in a bad condition and it is necessary to take him to the hospital and I accordingly reach there and took him to Anugerah Niketan Nursing Home, where the doctor informed us that Sunil Jaiswal has been stabbed at in his abdomen, and he was admitted there.

9) That it is partly done to mention that the unknown miscreants also snatched cash money of Rs. 80,000 (Rupees Eighty thousand only) and 1 mobile phone (Model - Apple iPhone - X too).

10) That presently my friend Suraj Jaiswal is fighting for his life and he is presently in a very worst condition.

11) That as because we were busy arranging proper Medical assistance for my friend Suraj Jaiswal that is why ~~we could not~~ hence there is a delay in lodging this Written Complaint.

So therefore, I hereby request you to kindly take necessary legal action against these unknown miscreants under proper provisions of law and obliged.
