I Smt. Manju Kumari Singh, wife of Sri Ankit Kumar Singh Resident of Jhauguri, New Chumta, PS- Matigara, Darjeeling had lodged a complaint against my husband and a case is still pending before the Ld. Judicial Magistrate 3rd Court at Siliguri bearing the case No. Misc Case No. 59 of 2018. Since the case is still pending and everything seems to go on my favor because of that my husband with the ill intention trying to forcefully compel me to withdraw the case and when I denied for the same he with the help of one of his friend namely Sachitanand Sahani S/O Late Ramanand Sahani of Khaprail Bazar assaulted me with a intent of disrobe me and with his cruel nature forced me and done cruelty against me. I have a single daughter and the Court has permitted me to have the custody of the child but my husband used force to take the child with himself and on 27/04/2023 at around 06:30 PM used filthy language against me and my parents and mentally harassed me and my family and threatened me to face dire consequences if I did not withdraw the case because of all this incident which took place me and my family is under the pressure and being scared and feeling danger for our lives.

So I beg to request you to look into the matter and lodge an FIR for the same and help me to rid of all the physical and mental harassment which I and my family is facing now.
