Sub: Information regarding theft in the Deptt. of FMT Mortuary, NBMC detected on 11.05.2023 at around 5:00PM.

Sir,

This is to inform you that on 11.05.23 at around 5:00 PM, the Mortuary Attendants saw smoke emanating from the room of the Cooling Chamber Air-conditioning Unit and informed me. I subsequently informed the Principal, NBMC and the Assistant Engineer, PWD Electrical, NBMC regarding it.

After reaching the Mortuary, the lock of the room was opened by the PWD Electrical Staff and when we entered, the room was filled with smoke. After the smoke cleared, we saw that the Cooling Chamber Air conditioning Units (8 Nos.) along with the copper tubing pipes were missing and the electrical wires had been cut and there were burnt wires lying around. The copper tubing pipes of the Air-conditioning Unit of the Dissection Hall were also seen to be stolen from the room of the Mortuary.

I then informed NBMC&H Out Post regarding the matter.
