13/05/2023, when I heard a car honking
horn very loudly outside my house which
continued for several minutes so I went to
the next room and tried to see from the
window and when I looked down I saw one
Mr Grand Prasad of Block A11 hanging my gate
and when I asked him why had he come there
he started abusing me with filthy languages
and even called me 3rd Class. I told him that
even we are educated and respected people
coming from respectable family then he became
more furious and started using filthy
languages.

Then I came down running to pacify
him and to stop him from shouting and I
opened my gate and pleaded him with
both joint hands (namaste) he he caught my

hands and tried to push me.

As I come from the weaker section of the society being a woman he has miserably abused me by words and also physically.

Therefore under his circumstances I would be highly obliged if you would take this matter into your consideration as every time he purposely tries to provoke my husband also who also comes from a tribal section of the society. He tries to defame me and my husband every time for reasons best known to him but hampering our image as well as giving us mental torture.
