After one month I was ready to pay the rest of the agreement amount and I asked for the possession he said please wait for 15 days more so that I can provide you the possession of the mentioned restaurant cum bar and also transfer my 40 percent share which is in the name of me & Moushumi Sarkar (my wife).

But he starts ignoring my calls, so many times I go to his office, he is not available there also.

After two months I saw him sitting in his office, I asked him to do the needful, he said don't worry, I will give you possession and transfer my shares to you within seven days, Again he disappeared for one to two months.

After being harassed by him in this matter I told him to return my advance amount then next day he called me in his office and paid me amount of two lakh rupees through cheque.

And for the remaining amount he is released to me three cheques For the Total Amount Of Rs. 11,00000/-

I received the cheques and he told me that you just deposit the check on the given date, you will get your money without fail.

I deposited the cheques on the mentioned dates but they bounced due to insufficient funds in his account.

After that I called him regarding cheque bounce and he started threatening me and said I will not give you a single paisa you are from Bihar and I have many channels in Bihar if I give instructions they will come and pick you up from your place and harm you and your family so this is better you forget about your money.

But this amount is very big for me , as I am only the income source of my family at home who is doing peaceful business in this safe state

I was calling him continuously but he was not answering but since few days I am continuously getting threat calls from unknown numbers from Bihar state and Bengal state they are demanding 20 lakhs ransom from me and threatening me if I am not paying them they will harm me and my family members.

This all mess is created by Sudhir Kumar Sarkar Instead of giving me my money back they are demanding ransom from me and they are also telling me that if you want to run your business smoothly you have to give us money and forget your advance money which you give as advance.

I was so under pressure that I wrote a mail to Nabanna but in my previous mail I Provide details of S Ahmed, P Lama and Shubham I have come to know from my personal resource that they are not involved in this matter.

Sudhir Kumar Sarkar is also threatening me that if you don't stop calling for your money then I will file an FIR against you that you are harassing me and trying to Harm me with the help of local goons.

If you been to any other police station they will not trust you because u belong to other state and i belong to west Bengal state and i have huge channel in police department and i cater to their needs from time to time so don't try to be act smart with me | after hearing his words I was scared so I approached directly in Nabanna. I am very worried for myself and my family after receiving such threatening calls.

Thus I request you to kindly take action against him and recover my pending amount along with market value interest because its almost more then three years, also provide me security from your side, I am ready to pay security cost as per government value in treasury.

I am providing you the copy of the agreement which was signed by him Xerox of bounced cheques along with their acknowledgment from the bank.

Sir please take an necessary action as soon as possible and provide me security from your side and i also request you to kindly record this complain at your good book and also acknowledge this matter for future reference.
