I, **Smt. Manisha Kurali**, D/O, Sri. Sufal Kurali, W/O, Sri. Sujit  
Dhara, R/O Pramathesh Barua Sarani, Rabindra Nagar, ward no.21  
of S.M.C ,P.S:- Siliguri, District:- Darjeeling, begs to report you the  
following facts:-

1. That Sri. Sujit Dhara, S/O, Late Kanai Lal Dhara, residing at  
Khalia Majipara, Chamrail Khalia, P.O:- Chamrail, P.S:- Lilua,  
District:- Howrach, Pin:- 711114 is my legally married Husband.  
Our marriage was solemnized on 20<sup>th</sup> November 2017 at my  
Father's house at Siliguri, (address as stated above) according  
to Hindu rites and customs in presence of the relatives, friend,  
well wishes of me and from side of said my husband and the  
same was registered on 05/03/2023.
2. That after marriage, my husband took me to my in-laws house  
at Khalia Majipara, Chamrail Khalia, P.O:- Chamrail, P.S:- Lilua,

District: - Howrah, Pin: - 711114, we started to live/ reside there together as Husband and wife in above-mentioned address.

3. That subsequently, one male child was born on 04/10/2018 at Aakash Hospital pvt. Ltd, Nazrul Sarani, Hakim Para, P.O:- Siliguri, District: - Darjeeling during our wedlock. His name is Master Soubarno Dhara, now he is in 5 years old. Subsequently, again I was conceived but my said allege husband had/has compelled to miscarriage of this issue by forcefully consumed me contraceptive pills.
4. That as per demand of my Husband and my in-law, my father gave different Gold Ornaments total weighing 10 bhories , Dressing Table etc. to my husband as Dowry.
5. That soon after going to my in-law's house after my marriage, my husband and his in-laws started to torture me both physically and mentally. They used to pick-up quarrel with me without any reason and used to abuse me by filthy and insulting language and used to assault me by fists and blows and by kicks .They did not use to provide proper food to me and also in time and did not provide proper cloths to me. Moreover, Nephew of my husband i.e. Anup Das (allege Person no. 2) (details as stated above) also staying at my matrimonial house and as much as, he used to pick up quarrel with me without any cogent reason, thus he used to mental torture upon me in regularly during my matrimonial tenure.

Even though, they (my in-laws) use to apply force upon me to do all menial works of my in-laws house and always treated me as their maid- servant. My said allege husband used to torture upon me in such way.

My husband is such torture upon me was increasing day by day from after one years of our marriage.

Whenever, I came to my Father's House and stay there for some time, during that period also my husband used to come at Siliguri and used to physically assault me in different ways coming to my Father's house (address as stated above ) and use to torture me both mentally and physically.

6. That my said allege husband, Sujit Dhara is constantly abusing me by filthy, insulting and obscene languages. For his acts and activities, I am passing our days in unrest and infer our safety and security is under threat, because of such facts being caused by him. For that reason, in the month of February,2023 I discovered/ knew one conceal facts/ hidden truth ,purports that my said allege husband was committed /engaged extra marital affair with one lady ,namely Mrs. Latika Doloi since prolong period & my husband willfully admitted that this above-mentioned relationship sustaining from 20 years back and it is continuing at present moment. He also told that she is my first love and he treated her as his first wife ,as because, he never deserted/ leaved from his paramour ( Mrs. Latika Dholai ) in his life.
7. That on the other hand, said Anup Das is extremely rowdy in nature and he belong to very bad reputation in locality of my matrimonial house (address as stated above), as a matter of fact, he is constantly mental abusing upon me and my old aged mother and father yet.
8. That on 17/03/2023 at 9 p.m ( at night ) my said allege husband and my in-laws forcefully drove out me and my minor son from my matrimonial house after assaulting me physically by fists and blows and by kicks and threatened me by saying that they would murder me if I come and enter to my matrimonial house any time in future. Finding no other alternative, I was passing in entire horrible night at Howrah Platform and any how I contact with my family members over mobile phone and thereafter tomorrow ,very early morning, my family members came to this spot and rescued me & my minor

son from this said platform and came to Siliguri and took shelter in my Father's house.

Therefore, I am living with lots of fear, anxiety, distress/ horrible condition at the present moment; indeed, I am a helpless woman, as much as, my old aged father & mother is living under immense distress condition and lots of social stigma & agony at the present moment.

Therefore, I requested you to take necessary action against the afore- said alleged persons, namely 1. **Sujit Dhara** and 2. **Anup Das**, otherwise, I will face immense prejudice/ drastic and painful situation, even I will lost my life in any time for administration of justice.
