Sir,

I SI Mrinal Basunia s/o Manmatha Basunia of Bhaktinagar Police Station, Siliguri Police Commissionerate after producing two accused persons namely (1) Pradip Pradhan-26yrs s/o Bishnu Pradhan of Namthang, Kalorey PS Namthang, Dist South Sikkim (Ph-7478249264) (2) Sonam Gurung-24yrs s/o Surja Bahadur Gurung of Karek, PS Namthang South Sikkim (Ph-9883492929 and seized articles viz:- (1) 30 (Thirty) bottles of REXTAS cough syrup composition with Chlorpheniramine Maleate 4mg & Codeine phosphate 10 mg each bottle containing 100 ML (2) 10 (Ten) bottles of ASCODEX- CD anti allergic cough syrup composition with Chlorpheniramine Maleate 4mg & Codeine phosphate 10 mg each bottle containing 100 ML (3) 64 (Sixty four) of Winspasmoforte capsules which composition with Tramadol hydrochloride-1P 50 mg Acetaminophen 1P 325 mg & Dicyclomine Hydrochloride 1P 10mg contained in a one big size paper cartoon do hereby lodged written complaint to the effect that on 27.04.23 at 19:40 hrs received reliable source information that two persons were coming from Matigara side towards Check post side through a vehicle (Truck) with huge quantity of narcotic substances to carry the same to Sikkim. It is reasonably believe that the persons possessing the truck containing cough syrup and capsules may escape from the scene if Police party did not reach the suitable place immediately. The information was reduced in writing vide Bhaktinagar Police Station GDE no. 1407 dated 27.04.23 and informed superiors about the plan of action in writing. Thereafter myself along with SI Srimanta Chatterjee, SI Koushik Raha, ASI Dipak Karmakar, C/374 Debraj Biswas, Const/1431 Dilip Barman, Const/915 Chandra Prakash Adhikary taking blank paper, wax, metal seal and knife and other kits left for Check post in front of Gananayak sales to work out the information vide Bhaktinagar PS GDE No-1408 dated 27.04.23. & MCC No-701/231 dated 27.04.23.

At 20.00 hours I along with officer and force reached at check post in front of Gananayak Sales, 2 ½ Mile and waiting there for said Truck also contacted the source who show us the persons with vehicle loaded with suspected to be contained cough syrup and capsules from a certain distance, I briefed all Officers and after few minutes found one Sikkim number Truck coming towards Check Post from Matigara sides. We detained the Truck having Registration No- SK01D/4234 we along with force to cordon the vehicle along with two persons as tactful as possible in order to thwart their escape from the scene. Meanwhile I called two independent witnesses namely 1) Anand Ray (6297712620) s/o Rameswar Ray of Promodnagar PO Salugara PS Bhaktinagar Dist Jalpaiguri and (2) Sourav Giri s/o Anil Giri of Prakashnagar Limbu busty ward No-42, PO Salugara PS Bhaktinagar Dist Jalpaiguri after apprising them about the information received requested them in written to remain present with us during

under NDPS act. I arrested them u/s 41 Cr.P.C. after explaining them about the ground of arrest issuing proper memo of arrest. Arrested accused persons along with seized articles brought to PS, seizure list and seized articles handed over to Malkhana dealing Officer under intimation to I.C. PS for keeping record in PS property register.

I therefore pray that a specific case u/s Narcotic Drugs and Psychotropic Substances Act 1985 may kindly be started against the accused persons namely (1) Pradip Pradhan-26yrs s/o Bishnu Pradhan of Namthang, Kalorey PS Namthang Dist South Sikkim (Ph-7478249264) (2) Sonam Gurung-24yrs s/o Surja Bahadur Gurung of Karek, PS Namthang South Sikkim and arrange for its investigation.
