Sir,

In producing herewith (05) Five arrested accused persons namely (1) Ananda Das-20yrs s/o Ganesh Das of Laxmi colony, ward No-44 PS Bhaktinagar Dist Jalpaiguri (2) Rikesh Chhetri-23yrs s/o Kiran Chhetri of Bariakhop, Soreng Near Govt School PS Soreng Dist West Sikkim (3) Rahul Tamang -29yrs s/o Ganesh Tamang of Sangrabdang, near Rabdang school PO Singtham East Sikkim (4) Hari Tamang-33yrs s/o Tanka Bahadur Tamang of Bhajani busty, PS Monpoo Dist Darjeeling and (5) Suraj Chhetri @ Jogesh Chhetri-24yrs s/o Lt Kumar Chhetri of Molli Bazar PS Molli West Sikkim arrested on 29.04.23 u/s- 41 Cr.P.C along with following seized articles viz: -

1. One iron rod measuring about 20 inch (approx) from the possession of accused Ananda Das which was kept on his right hand.
2. One iron rod measuring about 20 inch (approx) from the possession of accused Suraj Chhetri @ Jogesh Chhetri which was kept on his right hand.
3. One iron made Knife approx 8 inch from the possession of accused Hari Tamang which was kept on his right waist.
4. One vehicle (four wheeler) having plate no-SK06T/0181

I, SI Koushik Raha of Bhaktinagar Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that, on 29.04.23 at 00.05 hrs received a sources information that 10/12 youths have assembled at Fouji Math, Near Payara Singh Dhaba under Bhaktinagar PS for making preparation to commit dacoity in a house at Bhaktinagar PS area. The fact was diarized in G.D vide Bhaktinagar PS GDE No-1482 dated 29.04.23. Subsequently after sharing the information with my superiors and as per their direction, at 00.15 hrs myself along with SI Rantu Halder, SI Mrinal Basunia, ASI Dipak Karmakar, Const/1431 Dilip Barman, Const/374 Debraj Biswas, C/915 Chandra Prakash Adhikary along with kits left for the place to work out the information. This refers to Bhaktinagar PS G.D.E No 1483 dated 29.04.23. We reached at Fouji Math, Near Payara Singh Dhaba under Bhaktinagar PS at 00.25 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from that Place. Sensing the police has cordoned off, they tried to flee away but on hot chase we managed to apprehend above noted 05 (Five) accused persons along with seized articles as mentioned above. However, the other four persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a

house at Bhaktinagar PS area. They also stated that another four others were away from the spot. They are also used the above noted vehicle in this crime.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was made in between 01.20 hrs to 02.10 hrs) Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of arrest memo to them.

I accordingly brought the arrested accused persons along with seized article at Bhaktinagar Police Station for further investigation. During interrogation, they are stated that they are gathered at Fouji Math, Near Payara Singh Dhaba to commit Dacoity in a house at Bhaktinagar PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Ananda Das-20yrs s/o Ganesh Das of Laxmi colony, ward No-44 PS Bhaktinagar Dist Jalpaiguri (2) Rikesh Chhetri-23yrs s/o Kiran Chhetri of Bariakhop, Soreng Near Govt School PS Soreng Dist West Sikkim (3) Rahul Tamang -29yrs s/o Ganesh Tamang of Sangrabdang, near Rabdang school PO Singtham East Sikkim (4) Hari Tamang-33yrs s/o Tanka Bahadur Tamang of Bhajani busty, PS Monpoo Dist Darjeeling and (5) Suraj Chhetri @ Jogesh Chhetri-24yrs s/o Lt Kumar Chhetri of Molli Bazar PS Molli West Sikkim and four others and arrange for its investigation.
