I, Samir Ghosh, Son of Late S.C. Ghosh, Resident of Raja Rammohan Roy Road, Hakimpara, Post Office: & Police Station: Siliguri, District: Jalpaiguri, in the State of West Bengal would like to lodge one F.I.R. in the following way:

1. That I am a resident of above mentioned address and on 29-04-2023 at about 2:40 P.M., when I was standing in front of the gate of Amrapali Residency, Zilla Parisad Road, Don Bosco Colony, within S.M.C. Ward No: 41, P.S. Bhaktinagar one biker being vehicle no: WB-74-BB-0252, who was in a drunken condition coming recklessly from the side of Salesian College with his bike and due to his reckless driving he hit me with his bike and for that reason I got injured and received head injury on the left side of my head and also received injury in my left hand and also my mobile & Scooty being no: WB-74-BM-7585 has been damaged. It is not out of place to mention here that I was unconscious from this act of the said biker. And after that local people of the vicinity took me to the hospital wherein I was under treatment. It is to be mentioned here that from the local people I get to know that his name is Santu and he is a resident of ektiashal and his Mobile No is 9832096498 and the local people also informed me that the said Santu usually drives recklessly in drunken condition. It is

pertinent to mention here that at present I have not enough means to complete my treatment as my sister is undergoing dialysis at present.

I therefore pray before you to look into this matter and to take appropriate legal action against the said Santu and that should be done for the interest of justice.

P.S.: As I received head injury for that reason I was unable lodge the F.I.R. on the said date resultantly this delay has been caused.
