Sir,

In producing herewith one accused person namely Parbalal Roy-47yrs s/o Lt Subol Roy of Baikunthapally, ward no-41, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

1. 21 (Twenty one) bottles of Himalayan Gold 60up country spirit each bottle containing 600 ML which was packed in one big nylon bag.

I beg to report that I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Parbalal Roy-47yrs s/o Lt Subol Roy of Baikunthapally, ward no-41, PS Bhaktinagar Dist Jalpaiguri to the effect that on 08.0-5.23 at 16.20 hrs received a source information from Baikunthapally under Bhaktinagar PS that one person namely Parbalal Roy has gathered huge quantity of liquor in his house at Baikunthapally for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-366 dated 08.05.23. As per your kind instruction myself along with SI Mrinal Basunia, PSI Koushik Raha Const/1431 Dilip Barman, C/915 Chandra Prakash Adhikary proceeded to the PO to work out the information. At 16.40 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made in between 17.10 hrs to 18.20 hrs)

I therefore request you a specific case may kindly be started against the accused person namely Parbalal Roy-47yrs s/o Lt Subol Roy of Baikunthapally, ward no-41, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
