In producing herewith following articles under proper seizure list-

- 1) 12 (Twelve) bottles of Tuborg Beer(each bottle containing 650 ml)
- 2) 06 (Six) bottles of Kingfisher strong beer (each bottle containing 650 ml)
- 3) 06 (Six) bottles of old monk XXX Rum (each bottle containing 750 ml)

I, ASI Dipak Karmakar of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely 1.Rajesh Tamang (M/49yrs) s/o- Lt Kamal Tamang of Khola Chand Fapri, P.S- Bhaktinagar, Dist- Jalpaiguri to the effect that today on 09.05.2023 at 17.35 hrs while performing evening patrolling duty, received a source information that one person namely Rajesh Tamang (M/49yrs) is selling liquor in his house at Khola Chand Fapri under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with force- C/1431 Dilip Barman, C/915 Chandra Prakash Adhikari, C/374 Debraj Biswas CVF/ 014 Labanyamay Barman left PS vide Bhaktinagar PS GDE NO- 416 had been to Khola Chand Fapri under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by the source I along with my force cordoned the area. I held raid thorough search in that house in course of which I recovered the above noted bottles of liquors inside of his house. On being asked Rajesh Tamang (M/49yrs) could not produced any valid document in support of those bottles of liquors. I also examined the above noted accused person and it could be learnt that the above noted bottles of liquors were procured and stored by the above noted accused person illegally and who used to sell it to the local youths since last few months for his illegal gain. Accordingly, I seized the above noted bottles of liquors as alamats under proper seizure list. The search and seizure was made in between 21.05 hrs. to 21.35 hrs.

I, therefore pray before your good self that a specific case may kindly be initiated against 1.Rajesh Tamang (M/49yrs) s/o- Lt Kamal Tamang of Khola Chand Fapri, P.S- Bhaktinagar, Dist- Jalpaiguri under proper section of law

and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
