Sir,

In producing herewith one accused person namely Basudeb Saha-43yrs s/o Lt Birendra Nath Saha of Sharatchandrapally, Near Water Tank, Ward No-40 PS Bhaktinagar Dist Jalpaiguri along with seized articles:

- i) One Vivo mobile phone vide IMEI No-869599056841332 & 869599056841324 with Sim No-6296186889
- ii) One Blue colour Redme mobile phone vide IMEI no-867949048151724 & 867949048151732 with Sim no-9641390668
- iii) Cash Rs-6,900/ Six thousand nine hundred only in following denomination 500 x12=6,000/ and 100x09=900

I SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar PS do hereby would like to lodge this written complaint against the above noted accused person to the effect that today on 10.05.23 at around 22.10hrs received a reliable source information from Sharatchandrapally that some persons are engaged in a betting in the house of Basudeb Saha of Sarat Chandrapally, ward No-40, under PS Bhaktinagar, SPC. I forthwith informed IC PS and noted the fact in GD vide Bhaktinagar PS GDE No-470 dated 10.05.23. I accordingly along with SI Mrinal Basunia, SI Rantu Halder, ASI Dipak Karmakar, C/374 Debraj Biswas, C/1431 Dilip Barman and C/915 Chandra Prakash Adhikary all of PS Bhaktinagar, SPC left for Sarat Chandrapally, ward No-40 to work out the veracity of the information vide GDE No-471 dated 10.05.23.11. Meanwhile, I requested two local independent witnesses namely (1) Sushanta Shikdar (Ph-7063711325) s/o Megha Sikdar of Bancawar More, Khudiram colony, near Banshjar more, PS Bhaktinagar Dist Jalpaiguri and (2) Sumon Malakar (6295490048) s/o Lt Sanjit Malakar of Ashghar Chika more Telipara PS Bhaktinagar Dist Jalpaiguri to assist us informing them about the information, which they agreed. When we reached at the said house at about 22.45 hrs, on being identified by the source we conducted raid in the house of Basudeb Saha of Sarat Chandrapally, ward No-40. Inside the house we found that the above noted accused person being equipped with the above noted 02 (Two) number of Mobile phones were actively engaged in betting regarding ongoing IPL cricket match to be played between Delhi Capitals & Chennai super kings which commenced from 19.30 hrs. On being asked all the accused person confessed that he was running an organized racket on betting for the ongoing IPL cricket game through SKYEXCH mobile Apps.

During the raid continuous updates were being received in the mobile phones of Basudeb Saha regarding the ongoing cricket match in between Chennai Super King VS Delhi Capitals, current betting price of the IPL cricket. During interrogation, it came to learn from the accused person he is the owner of the house. One Ananda Saha his brother who came in his house to assist him during the betting process. But during raid he was absconding from his house.

Accordingly, I seized the above noted articles from the P.O in between 23:10 hrs to 23:45 hrs under proper seizure list duly signed by him in presence of two independent

witness and arrested the above noted accused person u/s 41 CrPc in a proper memo of arrest informing him the ground of arrest and took him into custody.

Hence, it is evident that the above noted accused person along with his brother Ananda Saha in pursuance of their criminal conspiracy were actively engaged in running of betting racket on the one going IPL Cricket match which was playing between Chennai Super King and Delhi Capitals for their wrongful gain and wrongful loss of others and cheating the public, undermining the game of Cricket.

Hence, you are requested to start a specific case under proper section of law against the above noted accused person namely (1) Basudeb Saha-43yrs s/o Lt Birendra Nath Saha of Sharatchandrapally, Near Water Tank, Ward No-40 PS Bhaktinagar Dist Jalpaiguri and (2) Ananda Saha s/o Lt Birendra Nath Saha of Do and to arrange for its investigation.
