 relating to the commission of a cognizable offence against one Prativa  
 Dewan and her family members.

Sir,  
 I, Shri. Suresh Sherpa, Son of late Kalo Sherpa resident of Rajafn, HSF Road, P.O. Balkanthapur,  
 P.S. Bhaktinagar, Dist Jalpaiguri, would like to inform you as follows:

1. I am a resident of Rajafn village where one Prativa Dewan c/o Nupu Tshiring was also residing in our village who is married to an officer of armed forces. That the said Prativa Dewan contacted me seeking immediate financial help citing her personal difficulties which was also supported by her husband and parents.
2. On being induced by the said Prativa Dewan who portrayed herself to be in need of immediate financial constraints citing several reasons to me and I believing her difficulties to be genuine and on sincere request of her husband and other family members, I assisted the said Prativa Dewan by lending her Rs. 50000/- on 16.02.2022 in Cash and Rs. 1,00,000/- on 18.09.2022 in Cash.
3. I paid the above amount to the said Prativa Dewan, but at that point of time I was unaware that she had collected money from other persons of the village also and sometime back when we were discussing about the said Prativa Dewan in our locality, we came to know that she has mislead all of us separately and has taken money from us on similar pretext.
4. The following persons have also lent money to the said Prativa Dewan as follows:

In total we gave her Rs. 17,50,000/- (Rupees Seventeen Lakhs Fifty Thousand only) as stated above and she promised and assured that each sum would be returned within a year.

5. That after waiting for a significant period of time when she did not return our money back to us, we reached her house and confronted her after which she said that she does not have money immediately but she would transfer her land in our favour. We thereafter sought for transfer of her land to which she agreed and said that she will do it within a week. Few days ago when we again went to her house we were shocked to see that she is no longer residing at her house. Immediately we went to Rumbi where her parents are staying and there we got to know that she is planning to leave the country and she has gone to Delhi for the said purpose. We contacted her husband over phone who instead of helping us threatened us of dire consequences if we sought for any money from him or his wife.
6. We have given money to the said Prativa Dewan who dishonestly induced us to give such money and now has been avoiding to return our money with an intention to cheat us. We gave the money on trust but she dishonestly misappropriated the same for her own use and has committed criminal breach of trust.
7. We have been a victim of a huge scam committed against us by the said Prativa Dewan who is now absconding and only her husband and her parents are having knowledge of her whereabouts.

Having left with no other alternatives I have come before you with this information and request you to look in to the matter and register a F.I.R. against the said Prativa Dewan and her family members under Section 420/406/506/34 of Indian Penal Code, 1860 and also ensure that she does not flee away from the country. We request you for immediate action against the said Prativa Dewan and her family members.
