Sir,

In producing herewith two arrested accused persons namely (1) Hajikul Sekh-35yrs s/o Lt Abdul Khalek of Vill Aurangabad Khana bari, PO- Doharpar PS Suti Dist Murshidabad and (2) Md Nur Alam-30yrs s/o Lt Saimuddin of Adarshanagar, ward No-4 Near Charak Math PS Siliguri Dist Darjeeling (not verified) along with the following seized articles under seizure as per seizure list:

(i) 01 (One) transparent zipper plastic packet containing 290 grams said to be Brown Sugar

(ii) 10 (Ten) packet of NITRAZEPAN-10 Tablets contains with Nitrazepam 10mg, each packet 100 tablet, total 100x10=1000 pcs of tablets found in a yellow colour bag.

(iii) One Android Vivo mobile phone having IMEI No-866403069510476/40 & 866403069510468/40

(iv) One iTel keypad phone having IMEI No-355406386837108

(v) One Bolero four wheeler vehicle having Registration No-WB73F/0682 (All the articles kept inside the vehicle and seized as shown and identified by the accused persons)

I, SI Mrinal Basunia of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused persons to the effect that on 15.05.23 at about 14.40 hrs, received a reliable source input that two male persons were coming from Darjeeling more side towards 2 1/2 Mile Check post side with huge quantity of brown Sugar through a Bolero vehicle for delivering the same to their designed customers at Siliguri area for their wrongful gain. The matter was diarized in Bhaktinagar PS vide Bhaktinagar PS GDE No. 690 dated 15.05.23 and subsequently, I informed the matter in written to the I/C Bhaktinagar PS, SPC and being directed, myself along with SI Rash Behari Saha, SI Binod Jha both of SOG, SPC and SI Rantu Halder, PSI Koushik Raha, ASI Dipak Karmakar, Const/374 Debraj Biswas, Const/915 Chandra Prakash Adhikary, Const/1431 Dilip Barman all are Bhaktinagar PS with investigation kit left for Sahidnagar More, NH-10 under PS-Bhaktinagar by govt. vehicle to verify the veracity of the information and waiting there vide Bhaktinagar PS GDE no. 691 dated 15.05.23 and M.C.C No- 854/2023 Dated 15.05.23.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter we reached at Sahidnagar More and meanwhile called two independent witnesses namely; (1) Ramnath Chowdhury s/o Jiban Chowdhury of

(2) Gopal Barman s/o Lt Uttam Barman of Haiderpara Ghugni more ward no-39 PS-
Bhaktinagar Dist Jalpaiguri and disclosed our identity and informed them about the
information in hand and requested them in writing to accompany us in the whole
process during search and seizure, if any and they gave in writing about their approval
to accompany Police during raid, search and seizure. Being accompanied by source
and the witnesses our whole police party started watching over the four wheelers
which were coming from Darjeeling More side and at about 15.20 hrs, on being pointed
by source found one Bolero vehicle having Registration No- WB73F/0682 with two
persons. After hot chase we detained said vehicle at Backside of P.C Mittal Bus stand
near North city apartment and we disclosed our identity and the information in hand
and stated them that they will be searched in persons for the purpose. At this, they
disclosing their name and address as noted above and also found that Md Nur Alam
was seat in driving seat and Hajikul Sekh was seat in side seat of driver. They are
admitted that they have illegally possessed brown sugar and Tablets in their
possession for selling the same to their designed customers as per requirement for
their wrongful gain.

I then gave them written notice to be searched in presence of Spl. Executive
Magistrate. Then he agreed to be searched in presence of Spl Executive magistrate.
Accordingly, I informed the matter to Sri Narendra Kalikotey, Assistant Commissioner
of Police (SB), SPC, as a Spl Executive Magistrate, regarding the interception of the
accused persons suspected to be possessed Brown Sugar, Tablets and requested him
to come at P.C Mittal Bus stand near North city apartment to remain present and to
supervise the search and seizure.

Accordingly at 16.05 hrs Sri Narendra Kalikotey, Assistant Commissioner of
Police (SB), SPC, arrived at the spot as a Spl Executive Magistrate and subsequently,
under his supervision in presence of witnesses the process of search of the detained
persons for conducted following all formalities keeping his decency and recovered the
above noted articles from the Joint possession of above noted accused persons.
Subsequently, being demanded in presence of Sri Narendra Kalikotey, Assistant
Commissioner of Police (SB), SPC as a Spl Executive Magistrate the detained persons
failed to produce any valid document in support of possessing of the brown sugar.

Thereafter, I weighted the recovered packet with the weighing instrument and
found total 290 grams said to be Brown Sugar and 1000 Pcs NITRAZEPAN-10 Tablets
which was kept inside the vehicle of above noted accused persons. Then, I seized the
above noted articles at the spot under proper seizure list duly signed by the
independent witnesses as shown by the accused persons. I also labeled and sealed all
the articles in presence of Sri Narendra Kalikotey, Assistant Commissioner of Police
(SB), SPC as a Spl Executive Magistrate and witnesses and accused persons. The
whole process of seizure was made in between 16.25 hrs to 17.10hrs.

Being further asked, the apprehend persons namely (1) Hajikul Sekh-35yrs s/o
Lt Abdul Khalek of Vill Aurangabad Khana bari, PO- Doharpar PS Suti Dist
Murshidabad and (2) Md Nur Alam-30yrs s/o Lt Saimuddin of Adarshanagar, ward No-
4 Near Charak Math PS Siliguri Dist Darjeeling admitted in presence of Sri Narendra
Kalikotey, Assistant Commissioner of Police (SB), SPC, SPC and other witnesses that
he procured the brown sugar and Tablets clandestinely from elsewhere for the purpose
of selling the same in high rate to their designed customer for their personal gain by

illegal means. They also disclosed that they have been dealing in such business of procuring and selling of brown sugar illegally for last few months.

Then, I arrested the above noted accused persons namely (1) Hajikul Sekh-35yrs s/o Lt Abdul Khalek of Vill Aurangabad Khana bari, PO- Doharpar PS Suti Dist Murshidabad and (2) Md Nur Alam-30yrs s/o Lt Saimuddin of Adarshanagar, ward No-4 Near Charak Math PS Siliguri Dist Darjeeling after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons (1) Hajikul Sekh-35yrs s/o Lt Abdul Khalek of Vill Aurangabad Khana bari, PO- Doharpar PS Suti Dist Murshidabad and (2) Md Nur Alam-30yrs s/o Lt Saimuddin of Adarshanagar, ward No-4 Near Charak Math PS Siliguri Dist Darjeeling (not verified) are involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act. The whole process during search, seizure and arrest was video graphed by the videographer Sri Nitai Chowdhury of Shivarampally, Haiderpara PS Bhaktinagar Dist Jalpaiguri.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely (1) Hajikul Sekh-35yrs s/o Lt Abdul Khalek of Vill Aurangabad Khana bari, PO- Doharpar PS Suti Dist Murshidabad and (2) Md Nur Alam-30yrs s/o Lt Saimuddin of Adarshanagar, ward No-4 Near Charak Math PS Siliguri Dist Darjeeling (not verified) and arrange for its investigation.
